24. THE JAMMU AND KASHMIR MUNICIPAL CORPORATION ACT (XXL of 2000)

Insertion of new section.—
After section 34-B, insert;
DISQUALIFICATION
ON THE GROUND OF
DEFECTION NOT TO
APPLY IN CASE OF
SPLIT

- "34-BB.- (1) A member of a Corporation shall not be disqualified under sub-section (1) of section 34-A where he and any other member of his original political party constitute the group representing a faction which has arisen as a result of split in his original political party and from the time of such split, such faction shall be deemed to be the political party to which he belongs for the purposes of sub-section (1) of section 34-A and to be his original political party for the purposes of this sub-section.
- (2) For the purposes of sub-section (1), the split of the original political party of a member of a Corporation shall be deemed to have taken place if and only if not less than two-third of the members of the political party concerned have agreed to such split,"
- Section 36.—
- In sub-section (1), for "elect one of its Councillors", substitute "elect through open ballot one of its Councillors"; and
- (ii) In sub-section (2) -
 - (a) for "five years from the date of his election as such", substitute "co-terminus with the term of the Corporation"; and
 - (b) after first proviso, add:-

"Provided further that the term of the Mayor and the Deputy Mayor who have been elected as such before the commencement of the Jammu and Kashmir Reorganisation (Adaptation of State Laws) Fifth Order, 2020 shall also be coterminus with the term of the Corporation.".

Section 37 .--

In sub-section (2), for "not less than one-half" substitute "not less than three-fourth"; and

25. THE JAMMU AND KASHMIR CIVIL SERVICES DECENTRALIZATION AND RECRUITMENT ACT (XVI of 2010)

Section 3A. - After sub-section (2), insert:-

"(3) Notwithstanding anything contained in sub-section (1), spouse of a domicile shall also be deemed to be a domicile for the purposes of sub-section (1)".

26. THE STAMP ACT, SAMVAT 1977 (1920 A.D) (XL of Svt. 1977)

Insertion of new section. After section 1, insert: -

"IA. The provisions incorporated in the Act by virtue of the Jammu and Kashmir Reorganization (Adaptation of State Laws) Fifth Order, 2020 shall come into force on such date as the Government may, by notification in the Official Gazette, appoint.".

Section 2. — (i) for clause (1), substitute,-
