**Minutes of the 10<sup>th</sup> General House meeting held on 28-11-2020 at 11:00 AM (Saturday) in the Council Hall of JMC.**

On 28-11-2020, 10<sup>th</sup> meeting of General House began with recitation of National Anthem. Thereafter, the Secretary, Jammu Municipal Corporation, with the permission of Chair read the welcome address and requested the Hon'ble Mayor to start the proceedings of the General House meeting.

The Hon'ble Mayor in his address to the House welcomed chairpersons, all Hon'ble Councillors & Officers/Officials of JMC. Hon'ble Mayor stated that due to COVID-19, there is a delay in holding the session of "General House" meeting and only Councillors and Officers of JMC are allowed to attend this session in order to follow the guidelines of COVID-19 issued by the Government. He appreciated one and all who worked hard to face the challenges of COVID-19 from bottom to top with the help of citizens of Jammu. Hon'ble Mayor further added that the situation in Jammu remains in control due to the blessings of the Almighty and all are still needed to be more cautious. He said that the Hon'ble Councillors contributed a lot to face this challenge. Hon'ble Mayor particularly appreciated the efforts of Hon'ble Councillor S. Succha Singh, Ward No. 31, who worked a lot during this pandemic. Hon'ble Mayor further stated that:

1. He congratulated all the Jammuites for placing the Chair in the name of "Guru Nanak Dev Ji" in the University of Jammu. Hon'ble Mayor requested Research Scholars and students to follow the guidelines of Guru Nanak Dev Ji.
2. 74<sup>th</sup> Amendments are being implemented in letter & spirit. This was all done due to the efforts by all the Hon'ble Councillors. He thanked one & all for this achievement.
3. 24 Crore parking project at Panjtiirthi has been started. A proposal of opening Restaurant /Coffee House there was also in consideration.
4. 50 Open Gyms are installed in most of the Wards and remaining 25 are to be installed shortly.
5. Rotaries had been beautified by JMC, Fountains are also installed.
6. Under AMRUT, 200 crore Nallah works started.
7. 70,000 Street Lights are also installed in JMC limits till now.
8. Approximately 20 crore project underway to put in place of transformers for street lights backup including 70 nos of High Mast lights and cable for street lights.
9. Besides there is shortage of staff in JMC, a lot of development works were taken up in JMC.
10. Steps are being taken for implementation of Recruitment rules in JMC.

11. A number of areas covered by Black topping of roads by the active efforts of Hon'ble Councillors.
12. PHE works are also being done to improve the water supply.
13. JDA works are also started due to the efforts of Hon'ble Councillors.
14. Floriculture department also doing their work well for improvement of Parks.
15. Smart City projects are also in progress, Light works are also being taken up at Bahu Fort & Mubarak Mandi at a cost of approximately 7 Crore as a part of Smart City Project. All the 4(four) Bridges also to be electrified / illuminated under Smart City Project shortly.
16. Vertical Garden work also in progress from Jewel to B.C road under Smart City Project.
17. Jamboo Zoo work also in progress, 50 crore more required for it. After completion, it would also improve tourism.
18. Gharana wet land also to be developed.
19. Gondola at Bahu Fort to Mohmaya Temple also started which attract Tourists and can improve Tourism of J&K(UT).
20. 2<sup>nd</sup> Phase of Gondola work from Mubarak Mandi to Mohmaya Temple is also in progress.
21. Artificial lake work also in progress.
22. Intelligent Traffic Lights were also installed at different chowks as a part of Smart City project.
23. Shall take up with Prime Minister of India for One Nigam One Nation.

**The Hon'ble Mayor submitted a proposal before the House that one separate XEn of UEED for JMC in order to make the functioning of UEED department in a better way.**

**The House accepted the proposal of Hon'ble Mayor with the deliberations that the matter shall be taken up with the Govt.**

**4. Resolution submitted by Hon'ble Chairman(Social Justice Standing Committee.)-Sh. Jeet Kumar.**

According to Jammu Municipal Corporation Act, 2000, Section 42 provides with the function of Corporation and its part b (VII) provides with safeguarding the interest of weaker section of the society. In the same context section 69-A of the Municipal Act 2000 provides for constitution of Basic Service Fund and its Sub-section (2) explains the allocation/marking of the funds. The following has been mentioned as:

"A Separate fund called "Basic Services to the Urban Poor Fund" shall be constituted by every Municipal Corporation for delivery of basic services to the urban poor including the inhabitants of slum areas".

Hence on the basis of above mentioned rules, a Basic Service Fund is mandatory and needs to be established imperatively in Jammu Municipal Corporation for upliftment of weaker and downtrodden masses of the society.

**Commissioner: Matter has already taken up with the Govt. Reminder will be issued.**

**5. Resolution submitted by Hon'ble Councillor - Sh. Pawan Singh (W.No.23)**

I have the privilege to mention that the state govt has initiated steps for making the cities of J&K into smart cities. In this regard, I am of the opinion that the said development works should be started from the Mohallas by developing infrastructure in sector of water supply, sewerage, drainage, green spaces etc.

In this regard, we must start it from mohallas by providing sewerage connection to house hold level, construction of individual household toilets and conversion of insanitary latrines into sanitary latrines and overall development from grass root level which will result into face lifting of Jammu city and overall development of mohallas may add to the vigorous success in making the city of temples as smart city in real sense.

Hon'ble Councillor Sh. Sanjay Baru also added in this resolution that Channels/Bye-Channels of irrigation department within JMC limits should also be beautified under Smart City Project. Irrigation bye-channels which are

It is to inform you that National Highway passes through Sainik Colony. In addition to Highway, railway line and roads to Chowdhi, Ratnuchak and Heritage School passes through the Colony. It is a pity that Jammu City which is known as "City of Temples" is witnessing the denigration and desecration of deities/Gods and Goddesses by the people in such a manner that is unacceptable both in terms of religious faith and in terms of being the inheritors of such a rich civilizational legacy.

As such there should be a clear law or provision to stop this practice immediately to denigrate our religion and culture and send a strong message among the masses to uphold our religious heritage.

Instead of this practice of using fixing of images of deities/Gods/Goddesses and other religious symbols as deterrent against those who pollute the private and public property and contaminate the open spaces; there should a comprehensive legal provision to penalize those people who dispose of waste and garbage or urinate on the walls of other people.

This should be treated as grave offence and brought within the ambit of law so that religious sensitivities are not taken for granted to set a bad example.
