Circular

Whereas the above titled case has been disposed of by the Division Bench of Hon'ble High Court on 06.03.2017. The observations / orders are reproduced as under:-

"While disposing of WPPIL No. 34/2012 by order dated 27.11.2015, this Court directed the respondents to take all the steps required to make the provisions of the Municipal Corporation Act operational by 30.04.2016.

The Government has notified the approved Master Plan in SRO No. 90 dated 03.03.2017 under section 11 of Jammu & Kashmir Development Act, 1970. It is stated in the said notification that the Master Plan of Jammu, 2032 as approved shall come into operation from the date of its issuance i.e. 03.03.2017. The said notification is taken in record".

Whereas vide notification SRO 90 dated: 3rd March 2017 the Government has notified the Master Plan of Jammu-2032, as approved and has directed that it shall come into operation from the date of issuance of this notification.

In pursuance to the above, it is hereby ordered that:-

- i. All the officers / sections heads of Municipal Corporation, Jammu shall adhere to the Master Plan-2032 in letter and spirit while dealing the cases / matters relevant thereto.
- ii. Sr. Town Planner / Building section to process the Building Permission cases with the provision of Municipal Corporation Act and in terms of Master Plan of Jammu-2032 notified vide SRO 90 dated: 3rd March 2017.
