## JAMMU MUNICIPAL CORPORATION TOWN HALL, JAMMU

Subject:- Establishment of street vending zone(s) / rehri zone(s) -

## -Notification thereof.

Whereas, Municipal Corporation Jammu has identified the following sites for Establishment of street vending zone(s) / rehri zone(s) within the limits of Jammu Municipal Corporation.

- Janipur Opp. SBI Bank
- Jeevan Nagar opp. Industrial Estate Digiana (Main Satwari-Gangyal road)
- Opposite Meridian hotel, near Shakuntala theatre.
- Below Fly Over (Indira Chowk)
- Municipal Mkt. opp. collection Point Parade Ground.
- Near Chanderbhaga Community Hall canal road
- Below Fly Over K. C. Chowk (B.C. Road Opp. Sabzi Mandi)
- Near Police Station Gandhi Nagar
- Near ITI Akhnoor Road, Jammu

Whereas, amongst the aforesaid sites, seven number of locations / zones were already identified and some of the licences were also issued thereto.

Whereas the Division Bench of Hon'ble High Court Srinagar in OWP (PIL) No. 458/2003 titled Kashmir Consumer Welfare Forum and anr. V/s Commissioner Transport & Ors in its order dated 19.04.2017 has directed as under:

"As far as the question of street vendors is concerned. The Divisional Commissioner, Jammu & Kashmir, Inspectors General of Police of both wings (Executive & Traffic), Senior Superintending of Police of both wings (executive Jammu / Srinagar and Traffic), Commissioners of Srinagar / Jammu Municipal Corporation, Vice Chairman SDA and JDA shall take all the necessary steps required for making the roads available for the plying of vehicles only and remove the vendors from the road and footpath to ensure that no trade takes place on the roads and footpaths".

Whereas, it has been decided to notify the aforesaid sites for street vendor/ rehri wala's ensuring the road available for the plying of vehicles thereby removing the vendors from the roads and footpaths in order to have free movement of the traffic as well public in general.

Consequent there-upon, it is hereby notified that:-

- 1. All the street vendors who have taken license(s) from Jammu Municipal Corporation are hereby informed through this notice to re-register themselves with Jammu Municipal Corporation (specifying options) within **fifteen (15)** days along with following self-attested documents to be permitted suitably to ply in the said rehri zones. After the expiry of said period, strict action against the rehries plying without license(s) / outside rehri zones / roads will be initiated which may include confiscation of the rehries along with material-thereof.
  - 4 passport size photographs
  - Residence proof (Ration Card / Electricity Bill) (For locals)
  - State Subject (PRC)
  - Aadhar Card
- 2. It is further ordered that in case vendor failed to re-register within stipulated period of 15 days , earlier registration / license, shall be deemed to have been canceled *abinitio* and his / her case for registration

shall be considered afresh thereafter (as and when fresh process of registration will be initiated). Moreover there shall be no fee / charges for re-registration who apply within the stipulated period of 15 days.

- 3. Certificate of vending shall be issued *inter alia* after fulfillment of following conditions:
  - i. That the vendor should be a preferably PRC / Aadhar Card Holder.
  - ii. He / she has no other means of livelihood.
- 4. The registered street vendors shall furnish an undertaking to the effect that.
  - He / she shall not transfer license / registration in any manner, whatsoever to any other person.
  - ii. Shall maintain cleanliness and public hygiene at the vending site / zones and adjoining area.
  - iii. Shall pay periodic charges for the civic amenities and facilities provided in the vending zone as determined by JMC or the government from time to time.
  - iv. Shall not carry out any vending in the no-vending zone or beyond the permissible limits.
- 5. No temporary / permanent structures / construction of any kind is permissible at the site.
- 6. The right to restrict, evict and relocate shall vests with the Jammu Municipal Corporation. The street vendor shall vacate the site forthwith after issuance of notice, if required in public interest.
- 7. The vendor shall pay due attention to public health and hygiene in the vending zone / vendors market and the adjoining area. She / he shall contribute to promote the collective disposal of waste in the vending zone / area. Vendor shall not dump any waste in drain, road side, open areas or any other unauthorized place.

- 8. The vendor shall not hamper the free movement of pedestrian and traffic in any way. Vendor shall operate from the edge of the road / street (if vending from a street) and shall not cause any obstruction to smooth movement of traffic or pedestrians or non-motorized vehicles. He shall ensure that his / her customers shall not do unauthorized parking next to his vending site.
- 9. The vendor shall not sell obnoxious, hazardous and polluting items. It is to be ensured that the quality of product and services provided to the public is as per the standards of public health, hygiene and safety laid down.
- 10. The street vendor must not create any noise or play any instrument or music for attracting the public or the customers.
- 11. The street vendor shall not carry out any unauthorized / illegal activity.
- 12. The street vendor shall vacate the vending site in case of emergency, for security reasons and if required for public purposes.
- 13. The street vendor shall not cause any damage to the public property. The street vendor shall repair immediately, at his / her cost, the damages that may have been (if any) caused to the public property as a result of negligence during the vending. The decision of the JMC will be final and binding upon the street vendor with regard to liability and quantum of damages to be paid by him / her.
- 14. Cooking shall not be allowed. Vendors selling food articles, including cooked foods must comply with all licensing regulations and provision of prevention of Food Safety and Standard Act, 2006.
- 15. The vendors shall not block the footpath or carry out vending on roads.

- 16. Fresh applications will be entertained as well within the stipulated period of **fifteen (15) days** and waiting list of eligible applicants will be maintained for consideration in future on availability of sites of Street Vending.
- 17. The license / registration will be suspended or cancelled, among other on the following grounds:
  - i. Unauthorized change of vending site.
- ii. Unruly behavior and causing nuisance.
- iii. Misrepresentation in the application for grant of license / Certificate of Street Vending.
- iv. On conviction for an offence including moral turpitude and violation of other terms and conditions.
- 18. No vendor shall be entitled for registration / license for more than one category of vending.
- 19. Street vendor selling food articles shall obtained license from the concerned authority under Food Safety & Standard Act as required under norms.
- 20. Street vendor shall not dump any waste in drain, roadside, open areas or any other unauthorized place.
- 21. The zone will be allotted to street vendors as per availability of zone / sites.
