CONDITIONS:

1. The original bid security in the form of CDR/FDR and cost of bid documents in shape of demand draft pledged in favour of Executive Engineer, Trikuta Division JMC Jammu along with hard copies of PAN Card, Registration card and Sales Tax duly self attested or by the Gazetted Officer should be sent to this on or before **20.12.2017 4.00 pm** through registered post, speed post, courier or by hand and tenders without these documents are liable for cancellation / rejection.
2. Prior to bidding sales tax clearance certificate of the proceeding year issued by sales Tax Deptt. must be uploaded and enclosed with the hard copy.
3. The bids shall be uploaded in electronic format on the website <http://jktenders.gov.in>. up to **20.12.2017** up to 1400 Hrs. The bids received will be opened at 1100 Hrs. on **21.12.2017** online.
4. The Department Reserves the right to disqualify any bidder who even uploads the bid documents but without submitting the original instrument in the office in time.
5. Registration card should have been renewed for the year 2017-18 well before the Date & receipt of tender.
6. All the items of work advertised in the BOQ / Rate list are to be executed as per the necessity at site with the permission of Engineer-in-charge of site.
7. In case the amount / rate quoted by the tenderer / bidder are:
 - More than 15% below of the advertised rates of SSR 2012 the bidder shall upload and enclose an additional security deposit in the shape of CDR @ 5% of the advertised amount at the time of initial bidding. Bids which fail in the above category & are not accompanied by the necessary additional security deposit shall be straightaway rejected.
8. Any item or items beyond the above advertised rate list / quantity schedule if found necessary during the execution of the said work shall be got executed only after getting the prior approval from the Competent Authorities and the same shall be paid as per overall appreciation / Depreciation offered by the bidder.
9. All the Self Help Group of engineers shall be governed by Govt. order No: 14-L&E of 2017 dated: 20.02.2017.
10. Key construction material will be supplied by the department viz-a-viz Cement, Bitumen, Tar Steel, PCC Slabs & drains available in the divisional stores shall be issued as per the prevailing stock rates.
11. **GST /Income Tax/Labour Cess. The rates quoted by the contractor shall be deemed to be inclusive of GST , Labour cess, sales Tax etc. applicable in J&K State shall be deducted from the gross amount of the contractors bill.**
12. **Allotment shall be issued after the receipt of administrative approval & availability of funds.**
13. **Penalty**
Failure of successful tenderer on account of improper specifications / non- sticking to time limit & non adherence to terms & conditions shall render him liable to action under laws in addition to penalties imposed 1 % per day of allotment amount by the JMC.
