3. Bids shall be received "on line" on or before [14-07-2017 at 1400 Hrs]. The bidder must possess Compatible Digital Signature Certificate (DSC) and proper user ID.
4. Hard Copies of Bids shall be received in the office of the [Commissioner, Municipal Corporation Jammu] on or before [15-07-2017 at 1400 Hrs].
5. A Bidder requiring any clarification of the bidding documents may ask questions on line in the e-procurement portal using his / her DSC provided the questions are raised within 10 days prior to the deadline for on-line submission of bids.
6. Bids received on line as well as in hard copies shall be opened at 1300 Hours on 17-07-2017 in the office of the Commissioner, Municipal Corporation Jammu in the presence of the bidders or their authorized representatives, who wish to be present. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
7. Bids must be accompanied by bid securing declaration form duly completed, Bid security and cost of bid documents including VAT of the amount as specified for the work in the table above.
8. The cost of bid documents shall be remitted in the shape of demand draft issued from any

Nationalized Scheduled Bank in favour of [Executive Engineer Sewerage & Drainage Division (West) Jammu] payable at Jammu.


9. The Bid security shall be in the form of CDR/FDR/Bank Guarantee pledged in the name of [Executive Engineer Sewerage & Drainage Division (West) Jammu] payable at Jammu.
10. The bidding documents contain all other details.
11. The Employer reserves the right to cancel any or all bids without assigning any reason therefor.
12. Confirmatory survey shall be carried out by successful bidder before start of work at his own cost and detailed drawings, site plan and L-Section to be submitted within 7 days from the date of allotment.
13. The rate quoted should be inclusive of carriage of material nothing extra shall be paid for the Carriages.
14. Nothing Extra shall be paid for Temporary diversion bund, Removal of mulba/ Garbage/slush/Work under foul Condition and dewatering, contractor should quote the rate of earthwork accordingly.
