TERMS & CONDITIONS:

1. Tenders without CDR / FDR & DD are liable for cancellation. Only valid CDR / FDR & DD of the prescribed amount should be attached with the each tender. Any deviation in this matter will be lead to rejection.
2. Prior to bidding sales tax clearance certificate of the proceeding year issued by sales Tax Deptt. must be uploaded and enclosed with the hard copy.
3. The bids shall be uploaded in electronic format on the website <http://jktenders.gov.in>.
4. The original instrument in respect of CDR/FDR & DD & others must be delivered to Executive Engineer, Trikuta Division by Registered post/Speed post / courier or by hand. On or before due date.
5. The Department Reserves the right to disqualify any bidder who even uploads the bid documents but without submitting the original instrument in the office in time.
6. Registration card should have been renewed for the year 2017-18 well before the Date & receipt of tender, if not the same shall be entertained only after production of proof of remittance of renewal fee in the concerned office (Ref. to GR).
7. In case the amount / rate quoted by the tenderer / bidder are:
 - * More than 15% below upto 25% below of the advertised rates of SSR 2012 the bidder shall upload and enclose an additional security deposit in the shape of CDR @ 5% of the advertised amount at the time of initial bidding. Bids which fail in the above category & are not accompanied by the necessary additional security deposit shall be straightaway rejected.
 - * If it is more than 25% below upto 35% below of the advertised rates of SSR 2012, the bidder shall upload and enclose an additional security deposit in the shape of CDR @ 10% of the advertised amount at the time of initial bidding. Bids which fail in the above category & are not accompanied by the necessary additional security deposit shall be straightaway rejected.

If it is more than 35% below upto 45% below of the advertised rates of SSR 2012 the bidder shall upload and enclose an additional security deposit in the shape of CDR @ 5% of the advertised amount at the time of initial bidding. Bids which fall in the above category & are not accompanied by the necessary additional security deposit shall be straightway rejected.
If it is more than 45% below the advertised rates of SSR 2012, it will be examined by the department and if found the rates are not workable, the tenders shall be straightway rejected.

8. All the Self Help Group of engineers shall be governed by Govt. order No: 14-L&E of 2017 dated: 20.02.2017.
9. Photocopies of pan card, registration card and sales tax should be self attested or attested by the Gazetted officer & should be uploaded on the system and the same documents along with valid CDR/FDR & DD should be sent to this office.
10. Key construction material will be supplied by the department viz-a-viz Cement, Bitumen, Tar Steel, Paver Tiles, PCC tiles, PCC Slabs & drains available in store shall be issued as per the prevailing stock rates.
