

**Special Condition:-**

1. After opening of the tender if the rates quoted by the lowest bidder is found to be Very high & value of work is more that the advertised, Lowest Bidder have to negotiate the quoted rates with the department .
2. In Item Rate Tenders the bidders offenly quote their rates high for the initial Items due to which the rest of items are left in halfway. The contractors are advised to quote their rates up to extent of 15% variation over the advertised rates and beyond that the rates shall not be considered. The Overall Tender with respect to the advertised costs shall be negotiated if found high.

2. The Bidding documents can be downloaded from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) from 18.00Hrs. 27-04-2017 to 11-05-2017 upto 18.00Hrs.
3. a. The Bids shall be deposited in electronic format on the website [www.jktenders.gov.in](http://www.jktenders.gov.in) on or before 11-05-2017 upto 18.00hrs.  
b. The complete bidding process will be online.  
c. The bids of bidders shall be opened online in the office of Executive Engineer, Sewerage & Drainage Division (West), Jammu on 13-05-2017 at 13.00Hrs.
4. Bid documents can be seen at and downloaded from the website [www.jktenders.gov.in](http://www.jktenders.gov.in) Bid documents containing qualifying criteria for bidders, specifications, bill of quantities, conditions and other details.

6. In case the bidder quotes 15% below the advertised amount (or 15% below of unit rate amount of advertised items in case of stage contracts), the contractor shall have to produce additional extra security of 5%, of the bid amount which shall be deposited by the contractor in shape of CDR/FDR duly pledged in favour of Executive Engineer S&D Division (West) Jammu within 5 days after opening of the financial bid of the Tender.

- 7 Bids must be accompanied by bid security and cost of Tender Document as specified in column 5 & 6 of the table payable at Jammu pledged in favour of Executive Engineer, Sewerage & Drainage Division (West), Jammu. Bid security will have to be in the form of CDR / FDR and shall have to be valid for six months or more after last date of receipt of Bid. The nonrefundable cost of downloaded tender documents in form of DD shall be in separate envelope with cover marking cost of document. The cost of tender documents shall be non-refundable. However, in case the department cancel the NIT's, due to any reason, before opening of tenders, the cost of tender document shall be refunded to the bidders.
- a. The original instruments/ documents in respect of cost of Documents, EMD and relevant technical bid documents etc. must be delivered to the Executive Engineer, Sewerage & Drainage Division (West), Jammu on or before 12.05.2017 upto 14.00Hrs., if the office happens to be closed on the date of receipt as specified, the EMD documents fee will be received on the next working day at the same time and venue.
8. The bid for the work shall remain open for acceptance for a period of 90 days from the date of opening of bids. If any bidder / tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
9. The estimate has been framed as per the SSR of 2012.
10. Instructions to bidders regarding e-tendering in process.
- a. The interested bidder can download the NIT / Bidding Documents from the [www.jktenders.gov.in](http://www.jktenders.gov.in)
- b. To participate in bidding process, bidders have to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000 to participate in online bidding. This certificate will be required for digitally signing the bid. Bidders can get above-mentioned Digital Signature Certificate from any approved vendors. The Bidders, who already possess valid (DSC) Digital Signature Certificate, need not to produce new Digital Signature Certificate.
- c. The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature. No proposal will be accepted in physical form. Bidders are advised to scan their documents at 100 DPI (Dots per inch) resolutions with Black and white format in PDF.
- d. Bids will be opened online as per time schedule mentioned in para 3(c).
- e. Before submission of online bids, bidders must ensure that scanned copies of all the necessary documents have been attached with bid.
- f. The department will not be responsible for any delay in online submission of bids whatsoever, reasons may be.
- g. All the required information for bid must be filled and submitted online.
- h. Bidders should get ready with the scanned copies of cost of documents & EMD as specified in the tender documents. 14. The Bidders are advised to visit the site of work and satisfy themselves regarding the status of E/work. The classification of E/work are fixed and no claim, whatever, on account of change of classification shall be entertained. The cross sections of E/work are fixed except otherwise specified and are to be signed by the contractor at the time of Nishan Dehi. The payment shall be made for the complete cross section only and no payment shall be entertained for the in the complete cross section. N.S.L shall be incorporated in the work register before the work is started and the successful contractor has to sign the X-section.
15. In case the last date of receipt of physical documents / opening of tenders is declared holiday on any account, the last date shall be treated automatically to have been extended to the next working day.
16. After allotment of work to the lowest tenderer, the contractor should ensure that its completion within the stipulated period and the date of start of work shall be reckoned from the 7<sup>th</sup> (seventh) day after date of allotment.
17. If contractor fails to start the work within the stipulated time it shall be presumed that he is not interested in executing the work and action under rules shall be taken against him. No separate notice will be issued for start of the work.
18. During the execution or delay in start of work, the allotment/contract shall be cancelled within 04 days of the single notice being served upon and the CDR deemed to be forfeited without any prior information and the same work shall be got executed by other agencies at your risk & Cost.
19. The service tax, Income Tax or any other tax shall be effective @ the prevailing rates fixed by the Govt. from time to time and shall be deducted out of work done amount payable to contractor which includes the cost of key construction materials as per instructions issued by the authorities concerned.
20. The contractor shall draw agreement deed with the department after the issue of allotment letter.
21. Any loss to the labourers during execution of work shall wholly-solely be the responsibility of the contractor.
22. The burjees shall be maintained at each X-Section and shall be removed only after proper checking by the Engineer Incharge.
23. The key construction material shall be procured by the contractor as per the specification mention below:-
