- 7. Conditional Bids will straightway be rejected. All Bids, in which any of the prescribed conditions is not fulfilled or rebate put forth by the Bidder, shall summarily be rejected.

a) Cover-A

- i) Scanned copy of CDR / FDR & Demand Draft from any Nationalized / scheduled Bank i(in original) against cost of bidding document.
- ii) Experience certificate to the effect that the firm have completed /commissioned 164 KLD or more at least two Septage treatment plant /sewerage treatment plants of 2 MLD capacity are more in the country successfully with the successful running certificates from the competent authority for whom the plants has been constructed and commissioned with their e-mail address / Phone Nos.
- iii) Certificate to the effect that the Firm's turnover for the last three years is Rs.15.00 Crores or more framed and issued by the registered Chartered Accountant and that of the Joint Venture Holder is Rs.5.00 Crores for the last three years issued by the Chartered Accountant.
- iv) Copy of companies / firms registration certificate duly renewed for the year 2016-17 both for lead Firm and JV Holder.
- v) Copy of TIN / PAN Number Firm and valid sale tax certificate from the Competent Authority.
- vi) Authority letter of A.S.P Technology Provider, reputed one duly singed and stamped.
- vii) Machinery Equipment, Technical staff certificate shall have to be produced by the bidder.

- 13. The bidder must clearly mention cost offers separately for Construction of Septage Treatment Plant including all allied works and 5 years 0&M cost for STP.
- 14. Bids must be accompanied by Cost of Document and EMD as mentioned in the above table in the form as specified. The **Demand Draft** on account of cost of bidding documents non refundable for the work shall be pledged to **Executive Engineer, S&D Division, West Jammu** & payable at jammu and Earnest Money in the shape of **CDR/FDR** shall be pledged to **Chief Engineer J&K UEED Suliman Complex Dalgate Srinagar UEED Srinagar/Camp office UEED Jammu** & payable at Srinagar/Jammu. - 17. Any bidder withdrawing his bid during the period of bid validity or makes any modifications in the terms and conditions of the bid.

- 19. To participate in bidding process, bidders have to get "Digital Signature Certificate (DSC) as per information technology Act-2000. Bidders can get digital certificate from any approved vendors.
- 20. The bidders have to submit their bids online in electronic format with digital signature. No financial bid will be accepted in physical form.
- 21. The department will not be responsible for delay in online submission due to any reasons.
- 22. Scanned copy of cost of tender document in the shape of Demand Draft and Earnest Money / in the shape of CDR / FDR pledged to Chief Engineer J&K UEE Department Srinagar/Jammu must be uploaded with the bid. The original Demand Draft (Cost of tender document) CDR / FDR (earnest money) and relevant documents to be submitted to the Chief Engineer J&K UEED Suliman Complex Dalgate Srinagar/Camp Jammu in the shape of hardcopy by registered post / courier / by hand before due date & time of submission of tender / as per time schedule specified.
- 23. The cost shall be quoted by the bidder entirely in Indian Rupees both in words and figures and shall be deemed to include price escalation and all taxes upto completion of the work unless otherwise specified.
- 24. Bidders are advised to use "My documents" area in their user on UEED e-Tendering portal to store such documents as are required.
- 25. The date of start of the work shall be reckoned after one month from the date of issue of LOI / contract allotment as the case may be. During this month lowest bidder will frame the design and get design approved from the competent authority as decided by the Department.
- 26. **Penalty for delay in completion:** In case of delay in completion of work beyond stipulated period of completion, penalty up-to maximum of 10% of the contract value shall be imposed for first six months of delay. In case the work is not completed even after expiry of delay period of Six months the department shall be free to get the work completed through alternate means at the risk and cost of the lowest bidders.
- 27. **Time extension:** Suitable time extension shall be granted in the event of delay due to force majeure.
- 28. **Restoration of work:** On completion of contract the contractor shall be responsible to remove all un-used material and restore all work at his own cost.
- 29. **Traffic Regulations:** The contractor is bound to adhere to traffic regulations as is applicable from time to time and ensure arrangements of smooth regulation of traffic during execution of work.
- 30. **Safety:** The contractor shall be responsible for all safety measures to the life and property of workers, machines and all activities at site of work.
 - 31. **Laws Governing the Contract:** The contract shall be governed by laws of the land.
- 32. Septage Treatment Plant shall predominately take care of SEWAGE generated from the septic tanks of area as per DPR and the treated effluent shall have to conform to the following standards.

BOD < 10mg/L
Suspended solids < 30mg/L
COD < 30mg/L
Ammonia / Nitrogen / Phosphorus < 5mg/L
Oil and grease < 5mg/L
Faecal Coliform < 1000mpn

- 34. The successful bidder has to get the design approved from the competent authority as decided by the Department. The cost on this account shall be borne by the bidder.
