The bidder must possess Compatible Digital Signature Certificate (DSC) and proper user ID .The department does not take any responsibility for the delay caused due to non-availability of internet connection or network traffic jam etc.
3. Lowest Bidder (L-1) shall submit Hard Copy of Bid Document in the office of the Joint Commissioner (W) , JMC, at the address given in the NIT within 05 (Five) days after the opening of Financial Bid/issuance of Letter of Acceptance
4. A Bidder requiring any clarification of the bidding documents may ask questions on line using the email given in NIT/ BD. No queries will be entertained after the pre-bid meeting. Clarifications/ Responses to queries raised prior to pre-bid meeting and during the pre-bid will be uploaded on the e-tendering portal.
5. Technical Bids received on line shall be opened on -15-06-2022 at # PM in the office of the Officer inviting bids at the address mentioned in the IFB in the presence of the bidders or their authorized representatives, who wish to be present. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on account of public holiday on the date of opening of the bids as specified, the bids will be opened on the next workingday at the same time and venue.
6. Bids must be accompanied by bid securing declaration form duly completed and cost of bid document of the amount as specified in the table above.
7. The payment for cost of bid document should be made through Demand Draft in favor of the Chief Accounts Officer, Jammu Municipal

Corporation, payable at Jammu or in shape of e- challan/single window challan of JMC pledged to Executive Engineer, JMC / Tender Fee Receipt through online payment through the JMC link <http://www.Jmcjammu.org/online-payment.html>
