

Traffic lighting reviewed

Acting on the directions of Commissioner Jammu Municipal Corporation Mr. Ramesh Kumar (IAS), and in Order to ensure smooth installation of Artificial Intelligent Lighting system, a team of officers comprising Mr. Rajesh Sharma (KAS), Joint Commissioner JMC, Ms. Nisha Nathyal SSP Traffic Jammu, Mr. Bali, AEE Electric JMC, representatives of PWD Deptt. and employees of M/S DIMITS, the company entrusted with the job of installation of Artificial Intelligent Lighting system in Jammu City conducted a tour of the different locations within the Jammu city to ensure smooth shifting to the new systems.

The team inspected the newly installed lighting system along the National Highway starting from Greater Kailash up to Qasim Nagar crossing. The concerned Departments were asked to make good the deficiencies, where ever noticed, so that the system is made functional fully in a smooth manner. The executing agency I.e. M/S DIMITS was asked to relocate the towers where ever the visibility to commuters was not proper. Besides, some towers were of short height and required increase in height which job was entrusted to the executing company. The PWD(R&B) Department was asked to make minor repairs and putting yellow lines, at specified locations on the road. The company was further asked to complete the job of installation of pending lights on an urgent basis.

JMC conducts drive against illegal Constructions/Encroachments

On the directions of Commissioner Jammu Municipal Corporation Mr. Ramesh Kumar (IAS), Joint Commissioner Administration Mr. Rajesh Sharma (KAS), along with Chief Enforcement Officer Mr. Rajesh Gupta, Enforcement Officer Mr. Kamni Kumar and Enforcement Staff while continuing the drive against the illegal constructions and encroachments undertook a day long extensive drive in the different parts of Jammu city.

During the drive two numbers of shops which were being raised unauthorisdelly without seeking permission from JMC were demolished at Qasim Nagar Jammu by pressing men and machinery into service. The demolition drive was conducted with the help of police force from Bahu Fort Police Station.

Besides this, the team also foiled an attempt of encroachment of lane at Trikuta nagar ext. by demolishing the Gate which was being erected by encroaching upon part of lane there.

The Jammu Municipal Corporation once again Appeals to the General Public to refrain from raising unauthorized construction/s failing which the demolition/sealing of the unauthorized structure will take place. Further it is also requested not to dump the building material on road/lane side which causes obstruction to the public and also hindrance in the smooth flow of vehicular traffic.

JMC Continues Demolition Drive

On the directions of Commissioner Jammu Municipal Corporation Mr. Ramesh Kumar (IAS), and under the supervision of Joint Commissioner Administration Mr. Rajesh Sharma (KAS), along with Enforcement Officer Mr. Kamni Kumar and enforcement Staff while continuing the drive vigourously against the unauthorized & illegal constructions undertook a drive in different parts of Jammu City.

During the drive the team noticed an ongoing commercial construction at Deeli area which was being raised unauthorisdelly without the permission of Jammu Municipal Corporation. The illegal construction was demolished on spot by pressing the staff & Labourers into service.

The Jammu Municipal Corporation once again Appeals to the General Public not to undertake the construction without seeking the permission from Jammu Municipal Corporation failing which the same may lead to demolition/sealing of unauthorized construction. Further it is also requested not to dump the building material on road/lane side which causes obstruction to the public and also hindrance in the smooth flow of vehicular traffic.

Anti encroachment drive by Jammu Municipal Corporation

On the instructions of Commissioner, Jammu Municipal Corporation Sh. Ramesh Kumar (IAS), Jammu Municipal Corporation today on 07.12.2017 continued its special drive against illegal rehries/pharies and encroachers causing traffic congestion and obstructing free movement of pedestrians on footpaths. The drive was conducted under the supervision of Assistant Commissioner (Rev.), JMC, Mrs. Vinakshi Koul (KAS) & Chief Enforcement Officer, Sh. Rajesh Gupta. During the drive Revenue Officers, Sh. Parmod Kumar, Sh. Parveen Gupta and Sh. Sunil Gupta of JMC & other Enforcement staff of JMC also accompanied the drive.

The drive was conducted in the areas viz City Chowk, Shalamar, Purani Mandi and Raj Tilak Road in old city. During the drive the enforcement team of Jammu Municipal Corporation removed encroachments and cleared the footpaths and pavements. The team seized 1 truck of material displayed by the shopkeepers/phariwalas in front of their shops and footpaths causing traffic congestion and free flow of pedestrians.

Jammu Municipal Corporation again appeals to the shopkeepers to keep their goods within their establishments to avoid penal action against them and vendors to ply their rehries only in the rehri zones established by Jammu Municipal Corporation.

JMC conducts drive against illegal Constructions

During the drive the ongoing construction of seven numbers of shops which were being raised unauthorisdely without seeking permission from JMC were demolished on spot at Preet Nagar Digiana Jammu by pressing enforcement staff and labourers into service.

The Jammu Municipal Corporation once again Appeals to the General Public to refrain from raising unauthorized construction/s failing which the demolition/sealing of the unauthorized structure will take place. Further it is also requested not to dump the building material on road/lane side which causes obstruction to the public and also hindrance in the smooth flow of vehicular traffic.

Workshop cum Awareness camp on dairy waste management organized by Jammu Municipal Corporation in collaboration with J&K State Pollution Control Board, Jammu.

On the directions of Commissioner JMC, Sh. Ramesh Kumar (IAS), The JMC in collaboration with J&K State Pollution Control Board Jammu organized a Workshop cum Awareness camp on dairy waste management for dairy unit owners running their dairies within JMC limits.

In order to provide technical guidance to dairy owners for management of dairy waste which is of specific type owing to its biodegradable nature and odour pollution problem, if not managed scientifically, this workshop cum awareness camp was organized. The **main objective of workshop was “Waste to Gold” with mission “Zero waste”**.

Detailed knowledge was imparted to dairy owners to handle two main types of wastes. viz., cattle dung & cattle urine. During discussions, three different technical options were explained, which are **practically feasible, cost effective and easy to operate** and dairy owners were motivated to adopt any of the technique as per their suitability and affordability. During the workshop.

Dr. Jaswant Singh, Municipal veterinary officer apprised the dairy owners about need and parameters required to ensure good health of animals and cleanliness of premises. He also appealed the dairy owners not to let free their animals on roads and streets as they not only cause traffic jams but sometimes it may lead to fatal accidents. **Sanjeev Kumar, ACF**, Food safety department also participated and discussed in detail the criteria required for registration of dairies.





Mrs. Anuradha, Solid waste management expert, J&K SPCB, Jammu explained about the compost making technique from cow dung and making of “**Panchgavyam**”, a unique medicine for plants as revival tonic that can utilize and convert all types of dairy wastes into a valuable product. She also stressed on the need to understand that actually it is resource management as dung and urine have their medicinal value in ayurveda since historic times besides having wonderful uses as bio-fertilizers / bio-insecticides.

Dr. Zafar Iqbal, expert solid waste management, DC, office Jammu also briefed about the vermi composting process and mechanical screening of vermi compost so produced.
