

Notification for election of Chairman of Standing Committee

Notification for election of Chairman of Standing Committee(s) of Jammu Municipal Corporation viz. Jammu Municipal Corporation demolished six illegal shop Structures

To further intensify the drive against illegal/un-authorized constructions, today Jammu Municipal Corporation demolished six illegal shop Structures constructed at Channi Rama. Demolition was done in the presence of Officers of Jammu Municipal Corporation with the assistance of police authorities and Executive Magistrate deputed for the purpose. The Commissioner, JMC stated that JMC shall continue such drives against those constructions which have been raised illegally/un-authorizedly without obtaining proper permission from JMC and added that JMC shall not tolerate any kind of violation in Master Plan-2032 and violator shall be dealt with under the relevant provisions of the law. The Commissioner, JMC further appeal to the general public to refrain from raising illegal constructions and get building plans approved for commercial and residential purpose and raise building according to approved building plan, failing which action as warranted under Jammu and Kashmir Control of Building Operation Act,1988 and Jammu and Kashmir, Municipal Corporation Act,2000 will be taken against the violators including sealing and demolition of the illegal structures. She added that JMC has introduced Online Building Permission Systems (OBPS) which is very user friendly through which the residents can get their building plans approved within the shortest possible time at their door steps. Even they don't require to come to office everything is available online.

Commissioner, JMC took stock of water bodies.

In the ongoing work for Rejuvenation of Water Bodies/Ponds falling under the Jurisdiction of Jammu Municipal Corporation, The Commissioner, JMC, Ms. Avny Lavasa (IAS) paid a visit to water body/pond situated at Radha Krishan Temple, Deeli and inspected the ongoing work for its Rejuvenation. The said pond is one of the sixty plus ponds falling under the Jurisdiction of Jammu Municipal Corporation. In this regard, Jammu Municipal Corporation invited proven technology for in-situ treatment of lake/pond water through Bio-remedial and Aeration Systems or equivalent technology. “To prevent and Rejuvenate existing natural water bodies by reducing the environment of degradation due to pollution, capacity augmentation and beautification of ponds through regenerative landscaping techniques to transform them into positive, vibrant and lively public open spaces.” The project is purely focussed upon reinstating the natural ecosystem and making water the water quality adequate to support life, increase surface water storage, sewerage management to ensure that the water bodies are not polluted any further and beautification of water bodies along with provision of necessary amenities within the project area.

Besides this, the Commissioner, JMC also visited the area from Narwal Bye Pass road National Highway and Rajeev Nagar, Qasim Nagar to Gujjar Nagar bridge area to took stock of sanitation scenario and on spot directions were given to the concerned Sanitation Officer as well as to the Transport Officer, JMC for focusing on providing better sanitation facilities in these areas so that these areas may be given aesthetic look.

During the visit Joint Commissioner (W), Executive Engineer, Division-I, Sanitation Officer and Transport Officer and other field staff were also present.

Commissioner, JMC conducts tour of Bhagwati Nagar dumping site

Today Commissioner, Jammu Municipal Corporation, Ms. Avny Lavasa (IAS) conducted the tour of dumping site at Bhagwati Nagar, Jammu accompanied by Chief Transport Officer, Zone-III and Transport Officer. She observed on ground scenario of dumping of waste and issued on spot directions to the concerned for proper and scientifically dumping of waste at site and added that waste should not be littered everywhere even road leading to the dumping site should be properly cleaned and waste should be lifted well in time.

She further directed the concerned for installation of dustbins wherever required so that people can put waste in the dustbins which will help to avoid littering of waste on roads and added that if there is any requirement of repair of machinery involved in dumping of waste at site should be brought into her knowledge so that can be no problem in executing the job. She stated that providing sanitation to the citizens is mandate of Jammu Municipal Corporation and that should be fulfilled in any manner for which every official/officer has to put their efforts for providing basic amenity to the citizens of the city.

Jammu Municipal Corporation conducts a surprise drive in different areas of Jammu City.

On the directions of Commissioner, JMC, Ms. Avny Lavasa, Municipal Veterinary Officer, Dr. Sushil Kumar Sharma along with other team members of JMC conducted a surprise drive in different areas of Jammu City to ensure the sale of wholesome and good quality meat and meat by products to the consumers. The surprise drive started from CPO chowk, and covered Amphalla, Janipur, Paloura Talab, Bantalab areas etc. During the drive, various meat shops, chicken shops & fish mongers were inspected and about 35 Kg of substandard meat was seized and later on disposed of properly along with a fine to the tune of Rs. 28000/- was also imposed to the meat sellers for selling unstamped & substandard meat.

Notices have already been served to various meat shops owners to install black colour glasses in their shops and do not hang the meat outside their shops. Meat & chicken shop owners were instructed to keep separate bins with black polythene to collect the daily waste generated on account of refused/inedible meat & chicken parts for further proper disposal through JMC vehicles.

Municipal Veterinary Officer has appealed to all the shopkeepers dealing with meat/chicken products to maintain hygienic environment in and around their shops and sale only stamped meat, also adhere with the directions & guidelines issued by the JMC from time to time so that good quality of meat shall reach to the consumers. It was also impressed upon all the meat sellers/handlers to ensure personal hygiene like wearing Masks, head caps, aprons and gloves and frequent using of hand sanitizers. He said that such surprise drives will be conducted on regular basis and strict action which may include sealing of shops shall be initiated against the defaulters.
