

## **JMC has started thermal Fogging in Jammu City to bring down Adult Mosquito Density.**

In view of reports of causes of Dengue in the Jammu City, The Jammu Municipal Corporation has intensified Area wise/Ward wise thermal fogging drive in Jammu city. The thermal fogging drive was started by Rajesh Sharma, (KAS) Joint Commissioner (A) JMC accompanied by Ranjit Singh (KAS) Secretary JMC, Joint Commissioner (W) Kushal Chand, Chief Enforcement Officer Rajesh Gupta and Chief Transport Officer Talat Mahmood Khan. Today drive started from Town Hall Complex of Jammu Municipal Corporation in collaboration with Malaria wing of Health Department. Under the thermal fogging drive today Gangyal Digyana, Nanak Nagar, Trikuta Nagar and adjoining areas etc. were covered. The Corporation has devised a calendar for the fogging to cover the whole city. The drive is launched to bring down the vector density of adult mosquitoes and to reduce impending danger of spread of mosquito born diseases.

The general public especially the old age and those allergic to smoke / asthmatics are requested to remain indoor during thermal fogging. Public in general is also requested to follow the preventive measures like:

- **Staying in well-screened houses.**
- **Wearing protective clothings.**
- **Using mosquito repellents and nets.**
- **Reducing mosquito habitats and breeding places.**

### **Thermal fogging drive within JMC limits.**

In continuation of intensified area wise/ward wise thermal fogging drive within the limits of Jammu Municipal Corporation, the areas of Ward No. 49 and 71 were covered viz. Tawi Vihar, Narwal, Pamposh Colony, Malik Market, Shanker Nagar, SOS Home lane, Rajuput Mohalla, Ravi Das Mohalla, Chakki Mohalla etc. under the overall supervision of Rajesh Sharma (KAS), Joint Commissioner (Adm), Jammu Municipal Corporation in collaboration with Malaria wing of Health Department. The Corporation has devised a calendar for the fogging to cover the whole city.

The main aim of thermal fogging drive is to make City diseases free, as mosquitoes are cause of so many diseases which are dangerous for human lives. Now-a-days the cases of Dengue is on high rise, to minimize the risk of Dengue, the Jammu Municipal Corporation is paying special attention towards eradicating mosquitoes menace by way of launching such drives.

The general public is also requested to extend their helping hands to make the thermal fogging is grand success so that chance of spreading diseases due to mosquitoes can be minimized upto large extent. The public is also requested to make their surroundings neat and clean by way of putting their waste into dustbins and do not get the water stagnated which is a main cause of spreading diseases.

## **Drive against the illegal dairy units within JMC limits.**

Taking serious note of the complaints pouring in JMC regarding menace created by illegal dairy units within the limits of Jammu Municipal Corporation, the Municipal Veterinary Officer (MVO), Dr. Jaswant Singh and Chief Enforcement Officer, Sh. Rajesh Gupta along with other staff of JMC initiated the drive against the illegal dairy units. During the drive JMC lifted animals from Chinore area with the assistance of police personnel of the concerned Police station.

Dr. Jaswant Singh, MVO said that most of the dairy owners have not constructed their cattle sheds properly, no proper disposal of cow dung is taking place and the same is being disposed off in the Municipal lanes/drains or dumped inside the dairy unit, sometimes dumped in the nearby vacant residential plots thus causing foul smell, health hazard, environmental pollution and insanitary conditions in and around the residential areas. Majority of the dairy owners after milking let loose their animals on roads and streets resulting in frequent traffic jams and accidents sometimes their death too.

JMC has issued notices to all the dairy owners running their units illegally within JMC limits to get them registered with JMC as per the framed guidelines, else close down or relocate them outside JMC limits but despite issuing notices from time to time, but no one have come forward for registration of their units. He further appealed to all the dairy owners to get their dairy units registered with JMC to properly maintain the hygienic conditions in and around the dairy units by doing proper disposal of cow dung. He also added that such drives will continue in near future as well.

## **Fogging Drive in different areas by Jammu Municipal Corporation**

To intensify the ongoing fogging drive, Jammu Municipal Corporation covered areas of Paloura Top, Janipur, Top Sherkhania, Old City, Nanak Nagar, Shaheedhi Chowk, Jewel, Dogra Chowk etc.. Fogging is being done twice in the same areas to eradicate the breeding of mosquitoes responsible for Dengue.

The inhabitants as well as Shopkeepers also assured their whole hearted cooperation to Jammu Municipal Corporation to conduct this kind of activities to make Jammu Dengue free.

The Joint Commissioner (A) JMC appealed the public in general to cooperate with Jammu Municipal Corporation in keeping Jammu Clean & Green and also avoid accumulation of water so that Dengue can be eradicated completely.

Among others Chief Transport Officer Mr. Tarik Raina, Health Officer, Dr. Anita Salgotra, Sanitation Officers, Transport officers, staff of Anti Malaria Department were also present during the drive.

Mr. Ramesh Kumar Commissioner reviews developmental works being undertaken under AMRUT by JMC, Smart City Projects, Intelligent Traffic Light System and Street Lights.

Mr. Ramesh Kumar (IAS), Commissioner Jammu Municipal Corporation conducted an extensive tour of Jammu City and inspected the ongoing Projects under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) as well as developmental works of the Corporation being executed at different sites viz. Multi-tier Car Parking at Panjtirithi, Multi-tier Car parking at Peerkho, Pedestrian Walkway at Peerkho, Green space at Jeevan Nagar etc. He gave on spot directions to the concerned officers for completion of ongoing developmental works in a time bound manner and also directed them to come up with bottlenecks, if any, for their early resolution.

The Commissioner further stressed upon the completion of the projects being undertaken by JMC under AMRUT, as these projects will play a vital role in making Jammu as one of the Smart City.

The Commissioner, Jammu Municipal Corporation also took stock of different areas where JMC has installed street lights in various wards & main roads in different vicinities. He issued on spot directions to the concerned Officers to make all the street lights functional and undertake repair wherever required. He added that it is the aim of the JMC to make Jammu fully illuminated and free from dark zones.

The Commissioner, JMC further directed the Engineers of Electric Wing of JMC to keep liaison with Power Development Department so that power connections could be given to the street lights to be installed in uncovered areas. He directed the concerned to replace the non-functional street lights on urgent basis.



He further reviewed the progress of installation of Intelligent Traffic Signal Light System (ITS) and gave directions for the commissioning of 20 Nos. new junctions and 15 existing junctions. He asked the executing firm to complete the work within stipulated time frame. He assured M/s. DIMITs of full cooperation from the Corporation in achieving the desired results within the fixed timelines. Mr. Ramesh Kumar, Commissioner, JMC also took review of the works to be undertaken under the Smart City Projects.

## **JMC conducts Anti Encroachment Drive**

The Jammu Municipal Corporation appeals to the shopkeepers and vendors not to encroach upon footpaths, pavements, road sides failing which strict action shall be taken against violators, as the encroachments lead to hindrances and creates lot of problems in free flow of vehicular as well as pedestrian movement.
