

Commissioner, JMC conducts tour of upcoming Solid Waste Management Plant at Kot Bhalwal.

Today Commissioner, Jammu Municipal Corporation accompanied by Secretary, Executive Engineer (Project), Chief Transport Officer, Zone-I&II and PMU Team visited the upcoming Solid Waste Management Plant at Kot Bhalwal, Jammu. During the visit she took stock of works undertaken by NAFED and issue regarding approach road to the landfill site was also discussed in detail and it was decided that NHAI will be approached for giving road link to the landfill site from ring road. Besides, issue with regard to Bio-remediation was also taken up for discussion.

She also observed on ground scenario of dumping of waste and issued on spot directions to the concerned for proper and scientifically dumping of waste at site and added that waste should not be littered everywhere even road leading to the dumping site should be properly cleaned and waste should be lifted well in time.

She further directed the concerned for installation of dustbins wherever required so that people can put waste in the dustbins which will help to avoid littering of waste on roads and added that if there is any requirement of repair of machinery involved in dumping of waste at site should be brought into her knowledge so that can be no problem in executing the job. She stated that providing sanitation to the citizens is mandate of Jammu Municipal Corporation and that should be fulfilled in any manner for which every official/officer has to put their efforts for providing basic amenity to the citizens of the city.

Commissioner, JMC conducts tour from Satwari Chowk to Purmandal.

Today a comprehensive tour was undertaken by the Commissioner, Jammu Municipal Corporation alongwith Joint Commissioner (A), Joint Commissioner (R&E), Secretary, Health Officer, Executive Engineer, Chief Transport Officer, Sanitation Officer and other field staff to take stock of the various sanitation and hygienic conditions of the whole stretch from Satwari Chowk to Purmandal. During the tour the Commissioner, JMC took note of sanitation related issues and issued on spot directions to the Health Officer and other field staff to pay proper attention towards the maintenance of the whole area. The Executive Engineer was instructed to start the work of retaining walls on the edge of some Nallahs and open drains. Similarly, Garden and Parks Section of JMC was directed to maintain the green patches along the whole stretch from Satwari Chowk to Purmandal in coordination with Urban Forestry Department.

Besides, some spots were identified for wall painting and beautification to be done under Jammu Smart City Project. The Health Section was directed to take note of littering hotspots and issue notices to the defaulters like scrap dealers etc. The Revenue Wing of JMC was directed to start removing encroachments on footpaths by street vendors etc. unauthorizedly.

Jammu Municipal Corporation today organized an awareness programme with **District Legal Services Authority, Jammu** - The aim of the awareness session was to disseminate information about various finer aspects of Swachh Bharat Mission as well as Solid Waste Management in Jammu city.

The programme started with a brief introduction of Swachh Bharat Mission which is – A country-wide campaign initiated by the Government of India in 2014 to eliminate open defecation and improve solid waste management.

Discussion on Solid waste management Rules 2016, J&K Solid Waste management Bye laws 2016, Plastic waste Management Rules 2016, C&D Waste Management Rules 2016 and SWM Fines and penalties were also made.

Inspection of Meat/ Chicken Shops on the eve of Eid-ul-Fiter

On the directions of Commissioner JMC, Ms. Avny Lavasa, IAS joint team of Jammu Municipal Corporation and Sheep Husbandry Deptt. Jammu under the supervision of Municipal Veterinary Officer, Dr. Sushil Kumar Sharma conducted a surprise drive of Meat/ Chicken Shops operating in different areas of Jammu City to ensure the sale of wholesome and good quality meat to the consumers on the eve of Eid-ul-Fiter. The drive started from Sidhra and covered CPO Chowk Panjtirthi, Newplot, Janipur, Bantalab, Paloura, B.C Road etc.

During the drive, various Meat/ Chicken shops were inspected and about 40 kg of sub standard meat was seized and later on disposed of properly along with a fine to the tune of Rs. 29,700/- was also imposed on the defaulters for selling unstamped/ unwholesome meat to the consumers.

Municipal Veterinary Officer, Dr. Sushil Kumar Sharma also gave on spot instructions to the Meat/ Chicken sellers to maintain hygienic environment in and around their shops and make availability of good quality meat to the consumers during the festive season. He said that such surprise checking will continue in near future as well to ensure that the consumers can get healthy, wholesome and disease free meat at Govt. approved rates.
