

Commissioner, JMC inspects ongoing constructions.

The Commissioner, Jammu Municipal Corporation, Ms. Avny Lavasa (IAS) carried out the inspection of ongoing construction for which the permission of stage-II Commercial/residential accorded by Jammu Municipal Corporation for verifying that constructions raised at site is as per approved building plan. The areas visited include Top Sherkhani, Digiana, Nowabad, Channi Himmat, Industrial Area Gangyal, Nanak Nagar and Bye pass road. The Commissioner, JMC issued instruction to the Enforcement Staff to keep a strict vigil on all the ongoing constructions to avoid any violation.

Besides this, In order to give boost to the Clean and Green Jammu, the Commissioner, Jammu Municipal Corporation today conducted tour of Ward No. 50, and 51 to take stock of the areas of Channi Himmat and Channi Rama alongwith Councillors, Smt. Neena Gupta and Sh. Raj Kumar on spot directions were issued to Sanitation Officer in this regard. She further directed to the concerned Executive Engineer for preparing the estimate to upgrade the drain at Surya Chowk, Channi Himmat, Jammu to resolve the issue of residents of the areas being faced by them due to the same. Directions were also issued to upgrade the common Cremation Ground of Ward No. 50 and 51 at the earliest.

The residents of the wards appreciated the efforts of Commissioner, JMC for providing better sanitation and other civic amenities in their respective areas and assured that they shall provide full cooperation to Jammu Municipal Corporation for maintaining sanitation upto to the satisfactory level.

- II. Sealed 05 No's of Shops of Mohd Farooq Khan S/o Sh. M.Y Khan at Channi Rama Opp Police Line, Jammu.
- III. Sealed 06 No's of shop of Rizwan Ali S/o Naziq Ali at Channi Rama Opp Police Line, Jammu.
- IV. Sealed shop of Sh. Bhagat Ram S/o Sh. Kanshi Ram at Main Road, Bhawani Nagar, Janipur, Jammu.

The action against the violation have been taken under the provisions of J&K Control of Building Operation Act, 1988 and J&K Municipal Corporation Act 2000

The Jammu Municipal Corporation once again appeals to General Public to refrain from encroachments and unauthorized constructions otherwise action as admissible under rule leading to demolition/sealing.
