Ms. Avny Lavasa(IAS), Commissioner, Jammu Municipal Corporation today convened a meeting with regard to provide better sanitation facilities to the citizens at their doorsteps.

Ms. Avny Lavasa (IAS), Commissioner, Jammu Municipal Corporation today convened a meeting with regard to provide better sanitation facilities to the citizens at their door steps and also to streamline the system wherein Ms. Tinna Mahajan (KAS), Secretary and Dr. Sanjogita Soodan, Health Officer were also present. With a view to maintain better sanitation and hygiene in the residential and commercial areas and also to stop disposal of garbage on roads, Jammu Municipal Corporation is taking every possible step to reach to expectations of the public in respect of maintaining sanitation upto to the mark. During the course of meeting certain directions were issued to Sanitary Inspectors/Sanitary Supervisors of all the 75 wards for focusing on sanitation of their respective wards and to collect user charges from residential and commercial areas so that revenue can be generated for Jammu Municipal Corporation and the same shall be utilized for development purpose in different wards.

She further directed that shopkeepers & Hoteliers and other businessman establishment owners be asked to handover the waste only to designated vehicles which have been kept exclusively for this purpose, as this practice will help in maintaining sanitation and desired that people should be made aware of the fine & penalties to be imposed on defaulters and violators as per municipal bye laws for littering and open dumping of garbage including (C&D) waste etc. the amount of fines & penalties for different violators and defaulters has already been notified by JMC through print and electronic media.



“Plastic Lao Thaila Pao Campaign” under Plastic Waste Management Programme supported by Jammu Municipal Corporation, Hindustan Coca Cola Beverages and UNDP

Jammu Municipal Corporation (JMC), Hindustan Coca-Cola Beverages Pvt Ltd (HCCB) and United Nations Development Programme (UNDP) joined hands to launch the **“Plastic Lao Thaila Pao”** campaign at **Bahu Plaza Gandhi Nagar Jammu**, here on Wednesday, 16th December 2020. This month long campaign was inaugurated by Sh. Chander Mohan Gupta (Hon’ble Mayor, JMC) ,and Advocate Purnima Sharma (Hon’ble Deputy Mayor, JMC) in presence of Sh Dheeraj Gupta, Principal Secretary, Housing and Urban Development Department , Govt of Jammu and Kashmir, Sh. Baldev Singh Billoria, Chairman Health and Sanitation Committee JMC, Ms. Avny Lavasa, Commissioner JMC, Ms.Tina Mahajan Secretary ,JMC ,Mr. Prabjot Sodhi, Head Circular Economy UNDP, Saneev Arora CEO Regional and Urban Development Agency and Mohammad Ameen Guroo City Lead UNDP.

This campaign which is being organized by implementation partner to UNDP **“Regional and Urban Development Agency Jammu”** is part of ongoing effort to spread awareness on the need for responsible plastic use and its disposal. As part of the campaign, a mini material recovery stall has been set up in the JDA premises of Bahu Plaza to promote sustainable waste management practices. The eco-exchange stall will be operative on all days till 15th January.2021 from 10:30 am to 5:00 pm wherein public and shopkeepers would be engaged to bring pieces of plastic and exchange the same for Thailas (cloth bags) that are environmentally friendly. As such, people are given one cloth bag for each set of 10 PET bottles, 10 pieces of mixed plastic products, 20 pieces of multi-layered plastics, (of at least 100 gms and above), 20 small mixed plastic products or 15 pieces of plastic bags (of normal size of 1-2 kg carrying capacity). The campaign also drives home the point that plastics have inherent value and they need to be recovered and recycled.



Reflecting on the larger objective of the “Plastic Lao Thaila Pao campaign”, Hon’ble Mayor Jammu Municipal Corporation said, “Our objective is to bring about behavioral change needed to responsibly segregate waste at source as a first step for recycling of plastic waste. The initial response has been quite encouraging and we are hopeful that the increasing awareness will eventually bring about effective and scientific management of plastic waste in Jammu city.

It was followed by the nukkad natak managed by IEC team of JMC under SBM wherein team desiminated message on managing plastic responsibly and at the end participants took the pledge to support sustainable waste management practices.

Ms. Tinna Mahajan , Secretary JMC and Nodel officer SBM thanked participants for the participation and assured to render all support to make Jammu Swachh and Swasth.

PET Bottle Crusher machines installed in Jammu City
