
Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 08.07.2020.

Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 08.07.2020.


Whereas the concerned CPIOs (JMC) were present but the appellant did not attend the hearing.
