Order

In exercise of the discretionary powers under Section-44 of Jammu Municipal Corporation Act, 2000, it is hereby ordered that no marriage buggies with animals, Cart with animals, Horse, pony, mule, donkey, camel shall be run without obtaining license from Jammu Municipal Corporation. The owners of the above said animals will have to fulfill the requisite conditions attached Annexure "A" to this order, The License and renewal fees shall be charged as under :

S.No.	Animals	License Fee	Renewal Fee (after 01 year)
1.	Marriage Buggies	Rs. 5000/-	Rs. 3000/- every year
2.	Horse Cart	Rs. 2500/-	Rs. 1500/- every year
3.	Horse	Rs. 2000/- (including RFID Tag)	Rs. 1000/- every year
4.	Pony	Rs. 2000/- (including RFID Tag)	Rs. 1000/- every year
5.	Mule	Rs. 2000/- (including RFID Tag)	Rs.1000/- every year
6.	Donkey	Rs. 2000/- (including RFID Tag)	Rs. 1000/- every year
7.	Camel	Rs. 2000/- (including RFID Tag)	Rs. 1000/- every year

The Corporation shall initiate a drive against those who do not comply with the orders from 01/04/2020 and if, anyone found plying animals without obtaining license and RFID tagging of animals from Jammu Municipal Corporation, the Animals shall be confiscated and a minimum penalty of Rs 10,000/- shall imposed on the violator .

Affidavit

License from JMC with the following conditions:

1. I will carry load on animals referred in S.No 1 to S.No 7 as prescribed under the Prevention of cruelty to Draught and pack animals rules 1965.
2. I will not use the Animal for more than 9 hrs in a day in aggregate.
3. I will not use animals for more than 5 hours continuously without a break or rest for the animals
4. I will not use the animals during day time when the temperature exceeds 37 degree C (99degree F) during the period between 12 pm noon and 3 pm and will carry bucket of water during summer for animal.
5. I shall not continue to keep or cause to keep in harness my animals for the purpose of drawing vehicle after disengaging it from work.
6. I shall not use any spiked stick or bit, harness or yoke with spikes, knobs or projection or any other sharp tackle or equipments which cause or likely to cause bruises, swelling ,abrasions or severe pain to the animals
7. I shall carry Fitness Certificate of animals from authorized veterinarian's obtained every 3 months regarding the health status of the animals
