### ORDER

In exercise of the Discretionary powers under Section 44 of the Jammu Municipal Corporation Act 2000, it is hereby ordered that no dairy unit shall be run without obtaining license from Jammu Municipal Corp. This order is also applicable to live stock owners in Jammu Municipal Limits having animals for individual sustenance. The owner of the dairy units have to fulfill the requisite conditions attached Annexure "A" to this order. The license and renewal fees shall be charged as under:-

The Corporation shall initiate a drive to close down all non complying dairy units from 1.3.2016

## Procedure and conditions required for obtaining license:

#### FOR THE PREMISES:

To obtain such license from the Corporation, following are the requisite documents:-

- a. Application form in the prescribed performa duly filled in. (form is available on JMC website or may be collected from the office of Municipal Veterinary officer, JMC)
- A dairy must first obtain a no objection certificate from the State Pollution Control Board and the Food Safety and Standards Authority.
- c. The dairy owner must provide a minimum of 5 meter square covered space for each large animal and grazing space in addition to that.
- d. There must be a veterinarian's certificate obtained every month regarding the health status of the animals.
- e. Overcrowding must be prevented and the young ones of the animals must not be separated before 5 months of age.

## FOR THE ANIMALS

For registration of animals, the identification of each animal will be required by Radio Frequency Identification Device.

## PROCEDURE:

- On receipt of application, field visit shall be conducted and report shall be submitted within 15 days of receipt of application by the Municipal Veterinary office of JMC.
- Upon receipt of the report, Municipal Veterinary officer shall grant/refuse NOC within 7 days from the receipt of the report. Refusal needs to be supported with reasons.
- Use of oxytocin, a schedule H drug, is prohibited in dairies unless prescribed by a veterinary officer. The illegal use of this drug is known to cause major health hazard among consumers of milk. Any violation found will be dealt with strictly.
- Any dairy causing public nuisance in the vicinity shall not be allowed to be registered.
- Any dairy unit which allows its animals to roam freely on the streets thereby creating public hazards shall be issued notice to remove the animals from residential area immediately, failing which such animals shall be impounded.
- The owner shall be given two weeks' time to improve or remove the nuisance failing which the such animals shall be put to auction or to sent to Goushala.
