Raj Kumar, Member of Public Health Sanitation Committee for the post of Chairman of Swacch Bharat Standing Committee, Social Justice Standing Committee and Public Health Sanitation Standing Committee.
- Now therefore, in exercise of the powers conferred under Regulation 50 of the Municipal Corporation (Procedure and Conduct of Business) Regulations 2005, I Chander Mohan Gupta, Mayor, Municipal Corporation, Jammu hereby declare members mentioned in the enclosed list as duly elected Chairpersons of the Standing Committee(s) unopposed mentioned therein.


