

Resolutions of the 4th meeting of General House held on 17-01-2019 at 11:00 am in the Council Hall of JMC.

Resolutions moved by Sh. Kamal singh jamwal, Hon'ble Councillor Ward No. 49

1. A Resolution was moved by Sh kamal singh jamwal, Hon'ble Councillor that Shifting of Trikuta Division Dogra Hall of Jammu Municipal Corporation to Town Hall, Jammu from present location on the plea that the wards which falls on the Southern side of Tawi Bridge are badly suffering due to far away distances. Besides, this there is no sufficient parking slots at present location of the division and all the councilors of south side are facing a lot of difficulties in mitigates the problems/difficulties of the general public on various angles.

As such there is immediate need for shifting of the said Division from Dogra hall to Town Hall for the general interest of the public.

Resolutions moved by Sh. Surinder Sharma, Hon'ble Councillor Ward No. 36

1. A Resolution was moved by Sh. Surinder Sharma, Hon'ble councillor ward no.36 that Original name of Jammu City is "**Jammu Tawi**". This fact is evident from the sign board put on at Railway Station Jammu, Stamp Impression on post letters and old office records. Therefore, I seek support of this house to rename Jammu City as Jammu Tawi which will help distinguish Jammu City from Jammu District and Jammu Province.

There are 75 wards but only 17 sanitary inspector are there.

So, it’s my humble request to the house please bring back sanitary inspector their own wing to fulfill the requirement of sanitary inspector in all wards.

Resolutions moved by Sh.Narotam Sharma ,Hon'ble Councillor Ward No. 3

1. A Resolution was moved by Sh.Narotam Sharma, Hon'ble Councillor Ward no 3 that Our Jammu, the city of temple has the tradition of welcoming our guests as well follow the culture of " ATHITI DEVO BHAV" as we consider guests as God and following this tradition the people of Jammu accommodated all migrants wit open heart but unfortunately under some conspiracy perhaps to vitiate the peaceful, cohesive and unified society of Jammu hundreds and thousand of foreign illegal intruders and immigrants have made their entry into Jammu region and are residing more particularly in different wards of JMC. These illegal foreign nationals from countries like Bangladesh and Myanmar commonly called as Rohingyas have entered Indian border illegally without any permission or documents from government of India. It is also alleged in several media news that they are also being involved in criminal and militancy related incidents. It is also reported in many media reports that these illegal settlers have managed to get Aadhar Cards, Ration Cards. Resolutions by Commissioner, Jammu Municipal Corporation.

1. Signing of MOU with Shuddhi (NGO) for waste management:

Jammu Municipal Corporation has no scientific waste management system and invariably all the waste has to be transported to the landfill site at Kot Bhalwal which is about 25 kms from the city centre. This entails huge transportation and landfill management and handling costs. Jammu Municipal Corporation is in process for taking up the pilot project with Shuddhi (NGO) for waste management in 5 wards. Shuddhi is an NGO with experience in the field which will partner with Jammu Municipal Corporation in organizing IEC activities and set up operating waste processing facilities at identified places with no financial implication on the part of JMC.

Besides NGT in its latest directions has emphasized 100% waste segregation for better waste management.

2. Engagement of SKCs for newly added and for extended wards through NGOs:

There is shortage of SKCs staff. It is very difficult for the JMC to deploy or transfer the already engaged SKCs staff in different wards to newly added wards. Engagement of SKCs for ward no. 72 to 75 and also in respect of

outsourced wards i.e. 52, 55, 56, 58, 59,60,62,63,64,65,66,67,68,69,70 through NGO to cope up with the shortage of SKCs staff.

The resolution was passed unanimously

3. Engagement of staff for electric section of JMC:

There is shortage of trained staff in electric section of JMC due to retirement, death of the trained staff. The wards of Jammu Municipal Corporation have also been increased from 71 to 75 in the last year. In order to meet up the requirement there is need for engagement of staff (15 no. of skilled electrician/Lineman and 25 unskilled labourers) for electric Division of JMC through NGO.
