In the light of the decision taken during the course of the above said meeting, the ULBs shall obtain the list of beneficiaries from elected representative indicating 100% saturation of beneficiaries under PMAY-U in their respective areas. A letter should also obtain from all the Hon'ble Corporators indicating 100% saturation of beneficiaries in their areas of jurisdiction."

Minutes of the meeting held under the chairmanship of Prpl. Secy. H&UDD in Meeting Hall 4th Floor Civil Secretariat, Srinagar on 11.07.2020 regarding review of PMAY-U beneficiaries identified in Urban areas and newly established MRDA areas in Jammu & Kashmir Divisions HFA- Urban.

### The list of participants is enclosed as Annexure-A

At the outset the Director Planning H&UDD welcomed the Prpl. Secy. H&UDD, Commissioners'/Directors' of both the Corporations/ULBs, DGMs of JK Housing Board and SLTCs/CLTCs.

Prpl. Secy. H&UDD pointed out that there is a pendency of 9571 cases which need to be uploaded within two day. He further pointed out that weekly meeting will be held with all the stakeholders including SLTCs/CLTCs so that the desired goals of the Mission are achieved in full. It was pointed out that the honorarium of SLTCs/CLTCs shall be released by the end of July 2020 subject to their performance

The following decisions have been taken in the meeting:-

- 1. SLTCs/CLTCs in consultation with the concerned Commissioner Corporations/ Director Urban Local Bodies shall provide the list of 9571 pending cases of beneficiaries within two days along with district/ULB-wise breakup conveyed by the Nodal Agency HFA-U i.e. JKHB which includes 2655 No. of pending cases from the earlier sanctioned 31807 cases and 6919 nos. of beneficiaries now proposed sanctioned in the ensuing SLSMC.
- 2. The concerned Dy. General Managers through Commissioner JMC/SMC, DULBK and DULBJ should furnish to the Admn. Department the updated list of sponsored, sanctioned, rejected alongwith reason of rejection and total No. of cases pending/received from various Corporators/ beneficiaries indicating the beneficiary code, Name of the beneficiary alongwith Aadhar No, date of sanctioning by the SLSMC, Date of sanction by MoH&UA, GoI etc . The said information/data should be made available to the Admn. Department by or before 31st July 2020. Nonsubmission of requisite information will be viewed seriously and will be recorded in the APRs of the officers as well as in the performance appraisal of SLTCs/CLTCs.(format enclosed as Annexure-A)
- 3. The SMC/JMC/DULBK/DULBJ shall hold the meeting with the elected public representatives of all the ULBs and obtained the list of beneficiaries from them indicating 100% saturation of beneficiaries under the Mission in their respective areas. A letter should be obtained from all the Corporators indicating 100% saturation of beneficiaries in their areas of jurisdiction.
- The 14073 beneficiaries have been identified in the MRDA area of Jammu Division. However the SLTCs/CLTCs shall re-verify these beneficiaries and obtain the NOC from the concerned BDO and the verified list should be certified by Sarpanchs of the

concerned panchyats. The village-wise information of potential beneficiaries should be submitted to the Admn. Department within 7 days through the concerned DGMs.

- 5. In order to increase the awareness of the Mission, it was decided that both the Municipal Corporations shall erect billboards at 4 places each indicating various features of the Mission and the mechanism of availing the assistance under the Scheme. Like-wise the DULBs shall erect two billboards 2 in each Municipal Council and one billboards in each Municipal Committee. The Nodal Agency i.e. JKHB shall prepare the design for these billboards both in English & in local languages (Hindi/Urdu) and seek the approval from the Mission Director HFA-U.
- 6. The Commissioner SMC/JMC and DULBK/J shall furnish the requirement of funds for the IEC. The whole process shall be completed with a period of 7 days. Besides, JKHB shall prepare a video clip highlighting the achievements of the scheme including the interview of beneficiaries who have been benefited under the Mission. He shall also prepare jingles for FM radios.
- 7. Director Finance, JKHB shall ensure that funds under various Heads should be released at the earliest and all the pending bills should be cleared forthwith as per the guidelines of the Mission and submit the Action Taken Report within a week's time to the Admn. Department.
- 8. The concerned Deputy General Managers and SLTCs/CLTCs shall submit weekly workdone report, on every Monday (Format enclosed as Annexure B&C)

The meeting ended with the vote of thanks to the Chair.
