Rapid urbanization has brought with it, new challenges relating to Municipal Administration, Financing and Service Delivery. The percentage of people living in urban areas in the country has considerably been increased as the survey report.

The 74<sup>th</sup> Constitutional Amendment Act (CAA) has sought to strengthen and empower the ULBs and gave greater responsibilities for urban planning, water supply, social and economic planning, slum up gradation, public health etc. A review of user charges for various municipal service requires a critical look.

Through article 243Y, the 74<sup>th</sup> amendment act made it is mandatory for the constitution of State Finance Commissions to review:

- (a) The principles which should govern:
  - i) The distribution between the State and the Municipalities of the net proceeds of the taxes, duties, tolls and fees livable by the State, which may be divided between them and the allocation between the Municipalities at all levels of their respective shares of such proceeds;

- ii) The determination of the taxes, duties, tolls and fee which may be assigned to or appropriated by the Municipalities;
- iii) The grants-in-aid to the Municipalities from the consolidated fund of the State;
- (b) The measures needed to improve the financial position of the municipalities;
- (c) Any other matter refferred to the Finance Commission by the Governor in the interest of sound finance of the Municipalities.

In the recent years, there has been a major paradigm shift in thinking about provisions of urban services, such as water supply, sewerage, street lighting etc. It is no longer considered that these services have to be provided by the local authority as free public goods or as obligatory service offered in return of general taxes levied by the Municipal Governments. Increasingly, these services are being viewed as commodities which are to be provided on commercially viable basis of general taxes levied by the Municipal Governments. Increasingly, these services are being viewed as commodities which are to be provided on commercially viable basis that is as good for which a service charge or user fee has to be paid, at times in addition to the general taxes paid by urban inhabitants. The service charge or user fee is no long-run expected to be adequate to meet the entire cost of supplying these services that is both capital cost and operation and maintenance cost. It is further to submit that in most of the corporations in the country, cess on petrol tanks/oil depots is charged and in the same manner, JMC should charged to make the Corporation financially sound.

The authority for the levy of Taxes and Fees is provided under Municipal Corporation Act 2000. The scope of the authority to levy taxes/fee as well as the purpose for which levy is made can be considered in the Corporation and it has been found that Oil tankers getting dispatched from the oil Depots of the Oil Companies located within the JMC limits which after collection by the oil companies shall be deposited in the Municipal Chest on monthly basis.

# The resolution was withdrawn after opposition from some Councillors that works pertaining to their wards do not figure in the list.

**3.** The NOC (Licence) is being granted to different establishments under section 324 of Jammu Municipal Corporation Act, 2000 and fee is being charged under Chapter VIII of the Jammu Municipal Corporation Act, 2000. The time period is being proposed under section 356 of Jammu Municipal Corporation Act, 2000.

The rates for NOC fee (License fee) levied by Jammu Municipal Corporation were notified vide order no. JMC/RB/988-92 Dt: 09.07.2015 copy placed as annexure "A". Now three years have passed and there is need to revise the existing rates keeping in view the increasing prices of the commodities and the service being provided by the JMC.

Further, Jammu Municipal Corporation at present is providing NOCs for 11 months only and there are some cases where applicants have demanded NOC for atleast three years. In view of this demand we may also keep provision for grant of NOC for three years subject to the condition that the applicant shall deposit the fee for three years at one time with 20% rebate in NOC fee being charged.

As such resolution/proposal is submitted for enhancement of 10% on annual as well on renewal fee with the following terms & conditions to this resolution.

- NOC shall be granted for three years by charging annual fee or renewal fee for three years as is applicable.
- Any new construction/alteration addition, if required, to be done shall only be undertaken after seeking proper permission from Jammu Municipal Corporation.
- 3. The applicant shall maintain hygiene and sanitation in and around the premises.
- 4. The applicant shall not use polythene bags.
- 5. The applicant shall make source segregation by the use of red & green bins & ensure mandatory composting of the organic waste generated in their premises & shall strictly abide by Municipal Solid Waste Rules, 2016.
- 6. The applicant shall tie up with waste pickers/registered recyclers for collection of inorganic waste.
- That the applicant shall adopt scientific measures for the disposal of the waste generated in the Hotel.
- 8. No Genset shall be installed outside the business premises/unit.
- In case anybody raises objection at any quarter, the applicant shall remove / shift the unit to some other possible site.
- The N.O.C. shall not condone the violations in Building Permission, if any, sanctioned by the Jammu Municipal Corporation.

- 11. The Jammu Municipal Corporation reserves the right to withdraw / cancel the N.O.C. in case it is found that facts have been concealed by the applicant at the time of submission of application.
- 12. This NOC only indicates the permissible land use of the site and in no way be construed as regularizing construction, if any, made in violation of Municipal Bye Laws.
- 13. The applicant shall provide parking space for vehicles as required under norms.
- 14. Any deviation or violation of conditions as laid above and if any objection is raised from any other quarter will render this NOC null & void ab initio.
- 15. This is subject to the NOC of Pollution Control Board, Power Development Department, Excise Department and Fire & Emergency Service and other connected department.

The commissioner, JMC seeks approval of the corporation to the above resolution / proposal.

### The resolution was passed unanimously.

- 4. Proposal for hiring of vehicles & machinery including nallah gang labour for Desilting of Nallah's & Deep Drains falling within the limits of JammuMunicipal Corporation.
- Ref:- Direction issued by Hon'ble Mayor during the General House meeting on 17.01.2019 and urgency shown there after by the Worthy Commissioner Jammu Municipal Corporation .

There are 171 Nallahs and 103 deep drains in the Municipal areas of Jammu region excluding extended wards. The Nallahs and deep drains require regular and periodical desilting specially before the onset of monsoon season so as to avoid any kind of mishappening and inconvenience to the general public. Some of the Nallahs and deep drains are very vulnerable and needs special attention otherwise these can cause major damage in the low lying areas of Jammu. In case of rains water overflows and enters into the houses of local residence. The desilting of Nallahs and deep drains

has been a big problem in monsoon season and therefore require special attention in the interest of general public.

Year before last, the desilting work started w.e.f. 1/2/2017 and we were able to desilt almost all the Nallahs well before the onset of monsoon season. More than 1.50 lac tons of silt was removed from most of the trouble creating Barsati Nallahs falling with in JMC limits. As a result it was after more than two decades that all the trouble shooting nallahs remained well under control. Many low lying areas (which gets flooded every year during monsoon) like Krishna Nagar, Shakti Nagar, Kabir Colony, Nanak Nagar, Talab Tillo, Deep Nagar, Vishal Nagar didn't witness any kind of flash flood & water logging during last monsoon season.

As your good self is aware of the fact that there is already shortage of machinery & vehicles in Tpt. Section of JMC and even not sufficient to lift the garbage from many areas.

Apart from this many vehicles (Specially Tippers) have become old and can't cope up with load of desilting of nallah & deep drains as the working conditions are comparatively tough in desilting as compared to lifting of Garbage.

Moreover the dumping site has been shifted from Bhagwati Nagar to Kot Bhalwal which adds 30-35 km mileage for each trip of vehicle thereby increasing the demand of tippers required for lifting. Besides this the area of JMC has also been extended by 4 wards & the nallahs of these wards require more indepts desilting as the same has not been cleared before inclusion in Jammu Municipal Corporation.

The process of desilting will be conducted in 03 Phase w.e.f. 01.02.2019 to 31.08.2019. The 1st phase will remove 70-80% of the silt from the nallahs before 1st heavy rainfall of monsoon season. 2nd and 3rd phase will remove blockade caused due to the heavy rains during monsoon season on vulnerable points of barsati (seasonal) nallah & deep drains falling within limits of JMC. 2nd and 3rd phase of desilting will be conducted w.e.f. 01.07.2019 to 31.08.2019 and will take care of whatever silt/mulba that comes during monsoon season.

In this context it is requested that following men & machinery are urgently required for lifting and safe disposal of desilted material to the dumping ground at Kot Bhalwal so that the process of daily garbage collection should not suffer at the cost of desilting of nallahs.

Since the last meeting of General House was held in the month January 2019 and since then General home meeting has been held so far held as such the said resolution is submitted before the corporation for post facto sanction.

### 5. Installation of GPS/VTS in Sanitation Vehicles of Jammu Municipal Corporation.

In order to improve efficiency of garbage lifting in different wards of Jammu Municipal Corporation and to stream line the process of deployment of vehicles in different wards it is proposed that all the sanitation vehicles may be fitted with GPS based VTS for proper monitoring and tracking of the vehicles. The details of different sanitation vehicles is as given below:-

The total financial implication in this shall be Rs .9, 70, 000/- (Nine Lakhs Seventy Thousand only) with monthly rent of Rs. 300/- per unit.

The resolution was passed unanimously.

- Attachment of Ambulance with JMC for onspot treatment an antirabies of neighbourhood animals.
- ii) Approval for development of JMC Cattle Pound/Goushala at vill. Seri Khurd Nagrota Jammu.
- The Animal rescue centre, Roop Nagar is very facility which is over burdened with influx of sick/injured stray dogs, horses, cows and i) buffaloes. JMC has also started the Animal Birth Control programme as per the requirement the burden has increased. With the help of only three vehicles JMC is doing this job which is not sufficient. The NGO namely 'Save Animal Value Environment' has given a proposal for treatment for for onspot Ambulance attachment of neighborhood animals belonging to her Society with JMC at Municipal Animal Care Centre, Roop Nagar with the condition that the Ambulance will be attached along with her (NGO) driver for no monetary consideration but Fuel and repairs will be the responsibility of the JMC.

The resolution was passed unanimously.

As per the order of Divisional Commissioner, Jammu the State land measuring 97 KL-11ML comprising Khasra No. 35 situated at vill. Seri Khurd Tehsil Nagrota Distt. Jammu has transfer in favour of JMC (Housing & Urban Dev. Deptt.) for shifting of animals of unregistered dairies/stray cattles in the Municipal limits of JMC by intervene of Hon'ble High Court ref. WPPIL No. 25/2017 SAVE (Save Animal Value Environment) v/s State of J&K and ors. Accordingly Hon'ble High Court develop immediate directions for the Pound/Goushala there. For this there is required a tentative cost of Rs. 10.00 crore. In first phase there is requirement of tentative cost of 5.00 crore. It is pertaining to mention that this is the good step from JMC site to develop a Modern sustainable JMC Cattle pound/Goushalla. For this JMC will control the menace of stray cattles in JMC limits, control the illegal dairies in JMC limits, control the cruelty of animals and to control the accidents of sick/injured stray animals as well as human lives. The JMC has to involve Dhyan Foundation for management of Cattle Pound and shall also explore the possibility of garnering CSR funding from PSU's for meeting the Capital expenditure of the project. In the event of the same meeting success, the funds under 14th FFC reserved for construction of the Cattle Pound in compliance to court judgement will be ploughed back.

The resolution was passed unanimously.

### 7. Accord of building permission for raising the construction over the existing ground floor.

People living within the limits of Jammu Municipal Corporation are approaching this office for obtaining permission for raising their constructions over the existing ground floors for accommodating their families but JMC is not granting permission where existing construction is in violation of building norms. The issue was also raised by the Hon'ble Councillors during the General House meeting held on 15.12.2018.

There are about 1300 B.P. case files are pending in JMC but there is no guidelines for according permission for raising construction over the existing ground floor which have already been constructed in violation or without the approval of competent authority.

Earlier the decisions with regard to accord permission for raising construction over the existing ground floor were taken from time to time by the BOCA. The latest decision was taken in this regard that such cases where existing construction is in violation of building norms and applicant wants to construct upper floors for residential purposes, such cases shall be charged for the portion which was not approved by the competent authority but within is the building norms @ Rs. 20/-per sft. for residential building and Rs. 200/- per sft. for commercial building. Besides, this, before undertaking construction over the existing ground floor, the applicant shall submit an affidavit in the shape of undertaking to be authenticated by the 1<sup>st</sup> Class Judicial Magistrate that he shall remove/dis-mantle the existing construction raised by him in violation before undertaking new construction.

The need of the hour is to take decision to accord permission for raising construction over the existing ground floor for clearing pendency of such cases and the applicants are pressing hard for the same.

According the decision taken by the building Permission Authority in its meeting dated 07.01.2019 is submitted for approval of the Corporation.

The resolution was passed unanimously.

8. Regularization of Contractual/ Casual Drivers, SKCs, Technical Asstts., Surveyors and Computer Operators against vacant posts:-

Presently following Contractual/Casual employees are working in Jammu Municipal Corporation viz. (i) 33 Contractual Drivers (ii) 15 Casual Computer Operators (iii) 6 Contractual Surveyors/Technical Asstts. (iv) 174 Casual SKCs. The Contractual/Casual employees are demanding regularization against the vacant posts and have gone on strike in support this demand.

In order to address their demand following is submitted for approval of the Corporation:

"Adjustment of Contractual Drivers having more than 7 years of service against the resultant vacant posts of Drivers/Cleaners.

Adjustment of Casual SKCs having completed 7 years of service against vacant post of SKCs.

Adjustment of remaining Contractual/Casual employees like Technical Asstts/Surveyors and Computer Operators against resultant posts like Cooks, Dawasaz, Helper, Midwife, Dog catcher etc. by re-designating the above posts as Helpers in the grade of 4440-7440+1300 till these are held by above Contractual/Casual workers as proposed".

The resolution was passed unanimously.

### 9. Deployment of Labour (SKC) in new areas including in old wards.

In order to ensure proper sanitation in the under mentioned wards, the utilization of services through NGO deploying Labour to JMC is the need of the hour as has been projected by the Health Officer & Hon'ble Councillors. The matter is placed before the "House "for Post facto approval. The details of the proposal is as under:
