

Resolutions Moved by Hon'ble Mayor, Hon'ble Dy. Mayor, Hon'ble Councillors & Commissioner for the General House meeting held on 15.12.2018.

Resolutions moved by Hon'ble Dy. Mayor, JMC.

1. A Jammu Jan Suraksha Yojana (scheme) has been introduced where under any citizen can install CCTVs at their houses (premises) @ Rs. 10,000/- which can be paid on monthly installment of Rs. 500/-. Besides Rs. 1.00 lakh insurance shall also provided to those who install the same, besides, this 5% share shall be provided to JMC by the firm which will be a source of revenue for JMC.

The Resolution was passed unanimously.

2. To initiate process with the Govt. for bring back the powers of Chief Executive Officer, Jammu Smart City Limited with the Commissioner, JMC on the analogy of most of the Smart Cities of India.

The Resolution was passed unanimously.

3. To initiate process with the Govt. of J&K for bringing back the powers of Food Adulteration checking and Food License into the jurisdiction of JMC.

The Resolution was passed unanimously.

4. Face lifting of entire JMC Complex.

The Resolution was passed unanimously.

5. Measures/Action should be taken against the encroachment of Nallah's especially in Chowadhi, Trikuta Nagar, Bathindi etc. areas.

The Resolution was passed unanimously.

6. Construction of Footpaths, toilet ramps for handicapped persons.

The Resolution was passed unanimously.

7. Refinement of Building Permission Laws to ease out public grievances related to building construction permits.

The Resolution was passed unanimously.

8. Enhancement of honorarium of Hon'ble Mayor, Hon'ble Dy. Mayor and Hon'ble Councillors from Rs. 10000/- per month, Rs. 7500/- per month and Rs. 6000/- per month to Rs. 1,25,000/- per month Rs. 1,00,000/- per month and Rs. 50,000/- per month respectively.

Matter to be taken up with the Government.

Resolutions moved by Prof. (Dr.) Youdhvir Singh, Hon'ble Councillor, W.No. 73.

1. A Resolution was moved by Prof. (Dr.) Youdhvir Singh, Hon'ble Councillor W.No. 73 that a Govt. land be identified in the respective areas with the help of Revenue Department to institute a Public/Municipal Libraries so that the youth having urge to study may get the facilities in that library to prepare for their exams-be it professional entrance test or academics. The said Resolution was also second by Sh. Sobat Ali, Hon'ble Councillor, W.No. 74, Sunjwan.

Some Hon'ble Councillors were not in favour of the same and further suggested that area wise survey be conducted so that libraries could be established where necessary.

2. A Resolution was moved by Prof. (Dr.) Youdhvir Singh, Hon'ble Councillor W.No. 73 that a project be initiated with immediate effect to give proper House Nos. and Lane Nos. to the house covering whole of the area in Municipal Corporation, Jammu and also the plan of the Lane no. and House no. be displayed mohalla-wise in the interest of visitors visiting in the area. This is must to make the Smart City of Jammu in Municipal Corporation, Jammu. The said Resolution was also second by Sh. Inder Singh, Hon'ble Councillor, W.No. 44, Nanak Nagar, Jammu.

The Resolution was passed unanimously.

3. A Resolution was moved by Prof. (Dr.) Youdhvir Singh, Hon'ble Councillor W.No. 73 that a passenger shed be installed on the road

side near Saint Peter Convent School, Karan Bagh, Gadigarh to facilitate the youngster, Women and the old people to wait while seating in the passenger shed during rainy and sunny days. It may also set discipline for the daily commuters of matador and bus service. The said Resolution was also seconded by Sh. Sham Lal, Hon'ble Coucillor, W.No. 48, Gorkha Nagar, Jammu.
