
Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 16.12.2017.


Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 16.12.2017.

Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 16.12.2017.

Whereas, the records were examined, and it has been found that applicant has not deposited the photostat charges as asked for. 


