
Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 16.11.2017.

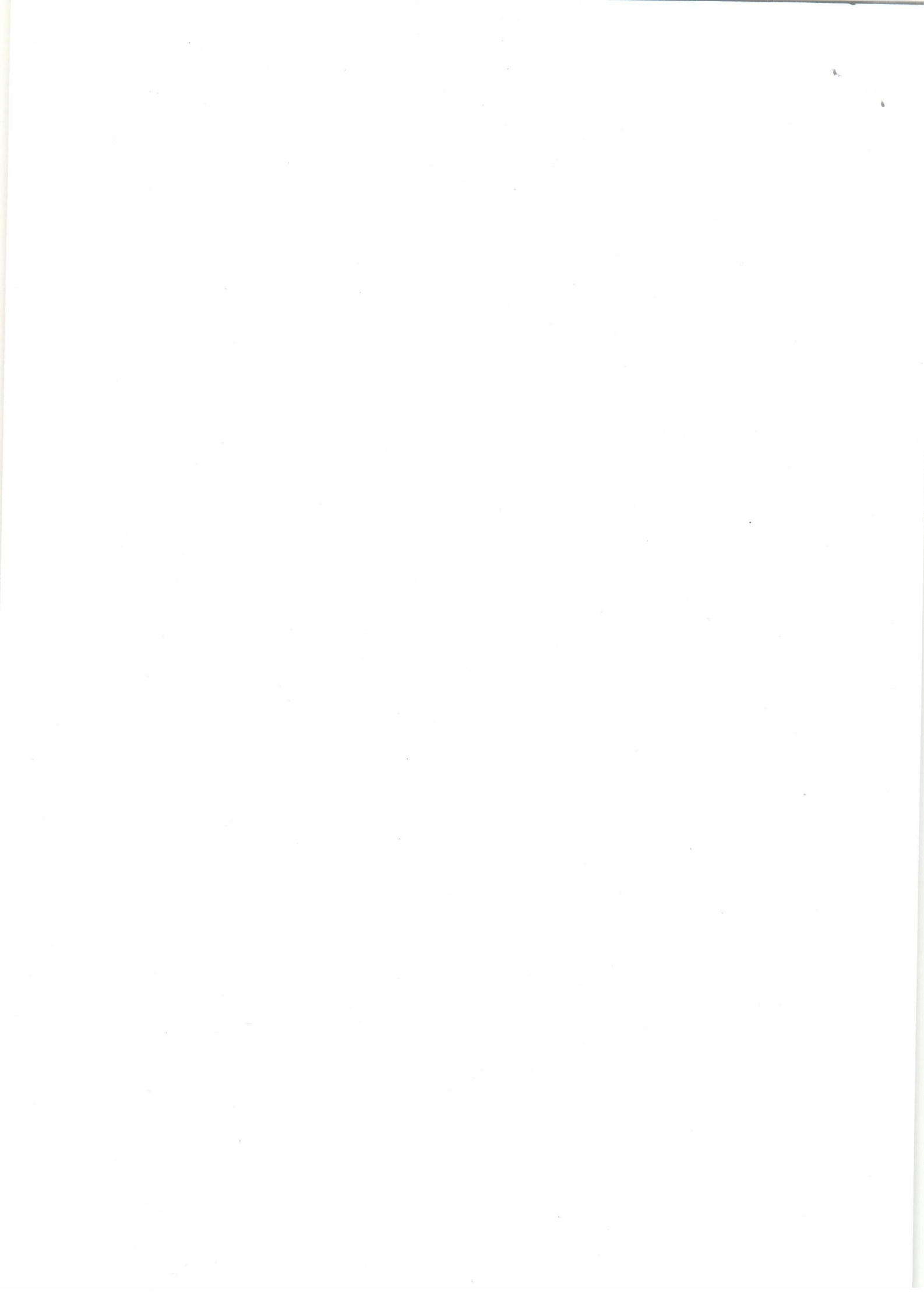
