Sub: Unauthorized Absence.

Whereas on 24.06.2016 you came in Health section under the influence of liquor and started abusive language in presence of staff and;

Whereas you thrashed Sh. Sohan lal Jr. Asstt. and Sh. Silwanis Bhatti, class-IV employee of JMC and;

Whereas about 3:55 P.M entered in the office of Health officer and used unparliamentarily language with staff present in the office and;

whereas you scrambled with Sh. Sohan lal and Silwanis Bhatti and also threatened them of dire consequences and;

Whereas Health Officer and other officials present in the office intervened to pacify the situation and;

Whereas the matter was telephonically brought to the notice of Police by the Health Officer to seek police assistance to avoid any untoward incident and;

Whereas you lodged fake complaint against Sh. Sohan lal Jr. Assistant and Silwanis Bhatti Class-IV employee in the Police post Hari Market Jammu and;

Whereas you were placed under suspension vide order No. MJ/Estt/3748-52 dated:2.07.2016 on account of creating nuisance / ugly seen and abusing officials under influence of liquor and also was attached with Transport yard Manda under the control of Chief Transport officer JMC till completion of disciplinary proceedings against you and;

Whereas a committee headed by Joint Commissioner (Adm.) JMC was constituted vide order no. MJ/Estt/3753-56 dated:2.07.2016 for conduct of enquiry in the matter and;

Whereas charge sheet was served to you vide No. MJ/Estt/4168-70 dated:16.07.2016 and;

Whereas you have submitted your reply on 25.07.2016 in reference to chargesheet no. MJ/Estt/4168-70 dated:16.07.2016 and;

Whereas while conducting enquiry the controlling officer CTO JMC was directed to submit your attendance and performance report vide no. MJ/Estt/5246-47 dated:11.08.2016 and number MJ/Estt/6792 dated:

10.09.2016 followed by latest reminder No. MJ/Estt/6089 dtd:31.10.2017 and;

Whereas the Chief Transport officer has reported vide no. JMC/TPT/955 dated:10.09.2016 and that you have neither joined nor performed any kind of duty in the transport yard (manda) Jammu and;


Whereas A.E.E(Transport) JMC was again directed vide No. MJ/Estt/6089 dated:31.10.2017 to submit your attendance / performance report and;

Whereas the controlling officer vide no. JMC/TPT/1137 dated: 13.11.2017 has again reported that you have neither submitted your joining report / nor performed duties in Transport Zone-I & II (Manda) Jammu and;

Whereas a show cause notice was served to you vide No. MJ/Estt/8452-58 dated:26.12.017 directing you to explain the reasons of unauthorized absence as reported by your controlling officer vide communication No. JMC/TPT/1137 dated:13.11.2017 that you have neither submitted your joining report nor perform duties in transport zone-I & II Manda Jammu and;

Whereas you have submitted your reply dated:4.01.2018 responding show cause notice No. MJ/Estt/8452-58 dated:26.12.2017 and the same has been examined in the light of notice dated 26.12.2017 and found that your reply is not based on the facts.

In view of above stated position a final opportunity is given to you with instruction to resume duties and explain your position on account of unauthorized prolonged absence within a weeks time in your defence failing which action shall be taken in terms of Article 108 J&K CSR Vol-I against you under rules.
