Order

Whereas, various resolutions were passed in the 9th General House Meeting held on 28.02.2020 and 29.02.2020 at the Jammu Municipal Corporation .

Whereas, the copy of the resolutions moved in the General House along with the minutes were duly submitted to the Administrative Department vide this office letter no. JMC/Estt/S/554-58 dated 08.06.2020 for consideration and further necessary action.

Whereas, the resolutions passed by the General House are as under:

- I. Circular Road, Metador Stand Panjthirthi shall be named as " Atal Ji Chowk" and City Chowk shall be renamed as "Bharat Mata Chowk".
- II. There is colony in my ward No. 47 namely Shahbad Colony. The name of the colony should be changed as Bahu Lochan Chowk.
- III. A statue of Raja Bahu Lochan should be installed near the Gandola Park Bahu Fort.
- IV. A statue of Late Shri Atal Bihari Vajpayee, Former Prime Minister of India shall be installed at Kachi Chawni Chowk.
- V. The name of the Ghass Mandi Chowk near Kanak Mandi & Lakhdatta Bazar, Jammu may be named in the name of late Lala Amar Nath Mahajan who remained Councilor in Seventies and Eighties and fought for the rights of people of Jammu in whole life and taken in jail during his struggle for the welfare of Jammu.
- VI. Installation of statue of Baba Banda Singh Bahadur in Kunjwani Chowk Jammu.
- VII. The name of 4th Bridge round above Chowk Bhagwati Nagar should be designated as "Baba Amar Nath Chowk" after the name of Barfani Baba Amarnath Jee.

Whereas, the Adm. Deptt. vide its communication No. HUD/JMC/40/2020 dated 02.07.2020 conveyed to take further necessary action under section 237 (1) (a) of the Municipal Corporation Act 2000.

Whereas, section 237 (1) (a) of the Municipal Corporation Act 2000 states as under:

237. Name and numbering to Streets:


(1) The Commissioner may—

(a) With sanction of the Corporation, determine the name or number by which any street or public place vested in the Corporation shall be known.

Now therefore, in exercise of the powers vested in me under section 237 (1) (a) of the Municipal Corporation Act, 2000 the above mentioned public places shall henceforth be known; as passed by way of resolution by the Corporation.
