**Subject: Bio-remediation of erstwhile dumping site at Bhagwati Nagar and management of dumping site at Kot Bhalwal Jammu in terms of SWM Rules 2016.**

**Order**

It is hereby ordered that:

1. Joint Commissioner (W) and Executive engineer (C) shall ensure erection of proper barrier / gate and fencing of the erstwhile dumping site at Bhagwati Nagar in order to prevent misuse of the site for dumping of any kind of solid waste by private or any government agencies in violation of directions of Hon'ble High Court. The concerned officers shall simultaneously take immediate steps for fencing of Kot Bhalwal site.
2. Dr. Mohd. Saleem Health Officer, JMC shall deploy two number of employees for taking watch and ward of the site during day and night (24 x 7) so as to prevent illegal dumping and its misuse. Sanitary Inspector / Supervisor / Nigran of the area concerned shall also be equally responsible for illegal dumping and misuse of the site. The health Officer shall further ensure that necessary steps are taken for segregation of the mixed solid waste at source with out any delay and all necessary steps for scientific disposal of the solid waste are taken in terms of SWM Rules and dumping site at Kot Bhalwal does not become health hazard and ensure that garbage is treated chemically.
3. Mr. Talat Mahmood AEE, (Transport) JMC shall ensure plantation (in addition to already about 200 plants have been planted before shifting) and leveling of the erstwhile dumping site Bhagwati Nagar with immediate effect. The officer concerned further shall ensure that all necessary steps for scientific disposal of the solid waste are taken in terms of SWM Rules and garbage is treated chemically at Kot Bhalwal site in co-ordination with Health Officer and other officers as may be required.

4. Dr. Zaffer Iqbal (MVO) Nodal Officer for SBM, JMC shall take all immediate steps for Bio- remediation, registration of ragpickers / waste collectors and self help groups with proper co-ordination with other officers of JMC as required in terms of SWM Rules.

**The officer shall furnish the action taken report within weeks time and any dereliction of duties shall be viewed seriously and warrant action against the defaulting officer / officials.**
