EXPRESSION OF INTEREST

Collection & processing of Cow Dung

1. Background

Jammu Municipal Corporation, the erstwhile Jammu Municipality was established after the reforms undertaken by Lord Rippan in the first quarter of 19th Century. The Provision of elective element in the Municipalities was introduced in the Year 1930. Next step towards the development of Municipality in the state was the passage of J & K Municipal Act in 1941. Subsequently, duly elected Jammu Municipal Council was superseded by the Government in 1960, 1975 and lastly 1983. In the 51st year of Republic of India, the State Legislature passed the J & K Municipal Corporation Act 2000, giving it status of Jammu Municipal Corporation. Since, Independence the Elections of Jammu Municipality have taken place five times only i.e., 1956, 1972, 1980, 2005 and 2018.

With the upgradation to the Status of Jammu Municipal Corporation (JMC), the city has been divided into 75 wards with an approximately area of 240 sq. km. These 75 wards are further grouped in to 3 Zones. The major division is based on the Tawi River passing through the centre of the corporation area. The upper area consists of Zone 1 & 2, whereas the lower part comes under Zone 3.

Due to being a prominent religious city there are many Gaushalas and dairy farms in Jammu, some operated by private parties and some operated by NGOs. The major environmental issues of dairy farms & goushalas are discharges of dung and urinal waste water. There are no scientific methods implemented for disposal of cow dung in the city as a result the dung going directly in drains and mixing with water, leading to the clogging of drains which becomes breeding ground for mosquitoes creating health hazards and odour nuisance. Due to this a large amount of water is also being polluted. To overcome such problems, Jammu Municipal Corporation wants a solution on collection & disposal of cow dung from every cow shed.

The disposal of cows/buffaloes dung is the biggest challenge in dairy farms & goushalas. However, cattle dung, if effectively utilized, can be a resource of manure and energy. The cattle dung contains many beneficial constituents which may be used as a fuel source either by direct combustion (dung wood) or converted to biogas, soil conditioner, fertilizer, material for wall plastering, construction of granaries/livestock & fish breeding, etc.

2. Aim & Objective:

Considering the environment and sanitation aspect Jammu Municipal Corporation is inviting the private party/NGO / Other for collecting the cow dung from all the private dairies and gaushalas and process it in safe manner. For processing the cow dung Jammu Municipal Corporation is willing to provide one Kanal land on lease basis for 3 year in Bandurakh where private Party/ NGO can setup the scientific disposal facility (Vermicomposting unit) of cow dung in self sustainable model. Party will be requested to do the fresh survey to quantify the generation of cow dung from the Dairies/Goushalas..

3. Eligibility criteria for the Participant

1. The APPLICANT should be of minimum 21 years of age (in case of individual APPLICANT).
2. Any private party / NGO/ other can participate in the EOI.
3. Party should have experience in waste management/ composting works;having sufficient number of required vehicles for collection of cow dung from gaushalas / Dairy Farms.
4. Party has to submit their technical and financial details at the time of meeting.

4. Terms & Conditions

1. APPLICANT shall be responsible for planning, preparation, engineering and execution of the project, including storage of raw material, operation and maintenance of the plant, maintaining final product output quantity and quality, managing the by-products and wastes from the plant as per existing central / state norms and providing performance guarantee for the project at their own cost.
2. To establish the collection, transportation and disposal of cow dung, Jammu Municipal Corporation will not provide any financial support to develop the basic infrastructure.
3. Jammu Municipal Corporation will not be responsible for providing any assistance in the sale of final product from cow dung.
4. All expenses related to Repair & Maintenance, Consumable, electricity etc. will be borne by the party. Jammu Municipal Corporation will not be responsible for any expenses.
5. Jammu Municipal Corporation will allot one Kanal land in Bandhurakh on lease basis for 3 years, extendable based on the performance review.
6. Party has to give revenue to the Jammu Municipal Corporation from 2nd year onwards which will be decided accordingly by the JMC.
7. An amount of Rs 50,000/- (Rupees Fifty Thousand only) is to be deposited as a security deposit for the agreement period and this amount shall be refunded to the party after 30 days of expiry of agreement.
8. Successful party has to sign the agreement with Jammu Municipal Corporation; all expenses related to the agreement shall be borne by the party.
9. All interested parties have to submit Copy of Certificate of Incorporation/registration certificate, PAN & GST registration Certificates, Experience certificates, Detailed project report along the application form.
