**Order**

- Whereas case was listed on 20.11.2018 / 03.12.2018, wherein series of direction have been passed for taking necessary action and filing a compliance report by or before **13.12.2018**.
- Since the case is listed on **13.12.2018** before the Hon'ble Chief Justice at Jammu. It is hereby ordered as under:
  - i. The committee(s) so constituted for the purpose are directed to furnish the action taken report.
  - ii. Secretary JMC to provide latest status / action taken with regard to defacement of public property and also to take pro-active steps by installing hoardings, jinglings or shot films on electronic media with regard to penalties for defacement and littering.
  - iii. Action taken report be furnished **by or before 10.12.2018** positively.



- The team shall identify the unauthorized and illegal constructions in the catchment areas of river Tawi and also share details of illegal structure with police so that necessary action is initiated.
