Whereas, after notice to the parties in appeal, the matter was taken up for hearing on 12.04.2017.


Whereas appellant chosen not to attend on 12.04.2017 i.e the date of hearing while the concerned officers of JMC were present.

Pursuant thereto, appeal was fixed for re-hearing on 05.05.2017 and appellant was provided opportunity who was present on the said scheduled date.

Kumar submitted that the measurement of land mentioned and permission granted to the area is not actually existing for which it has been decided that mater will be dealt separately in accordance with the rules.



Subject: Conduct of enquiry.

During the scrutiny of records pertaining to the application filed by S. Commissioner (R), JMC is appointed as enquiry officer who shall conduct detailed enquiry regarding measurement of the land / area in question alongwith revenue records.
