

Subject: Sanitation / cleanliness of Hon'ble High Court and District Court Complex, Janipur Road, Jammu.

Order

- Whereas vide communication No. 152/MMJ dated: 08.06.2017, Ld Special Municipal Mobile Magistrate has intimated that meeting was convened by the Hon'ble Mr. Justice Ramalingam Sudhakar, Administrative Judge for District Jammu on 8th of June, 2017 in the office chamber of Ld Pr. District Judge Jammu and same was attended by all the Judicial Officers posted at Head Quarter besides president Bar Association, Jammu and his office bearers.
- Whereas it has been further conveyed that his Lordships (Hon'ble Mr. Justice Ramalingam Sudhakar), has expressed displeasure and dissatisfaction over the sanitation in and around the Court Complex.
- Whereas Principal District judge, Jammu was directed by the Hon'ble Administrative Judge to nominate any officer of the District Court to monitor the sanitation of the Court Complex (High Court and District Court).
- Whereas Ld Special Municipal Mobile Magistrate has been nominated as Incharge of the committee to ensure that the Court Complex in and around is made spick and span.
- In view of the above it hereby ordered as under:-
 - i. That Health Officer, JMC shall conduct a sanitation drive(s) in the court complex (High Court & District Court) on **08.07.2017 and 10.07.2017 after 1:30 PM** in consultation with Ld Special Municipal Mobile Magistrate, Jammu and ensure that Court Complex in and around is made neat and clean.
 - ii. That Health Officer, JMC is directed to increase the manpower as may be required while conducting the sanitation drive(s) in the court complex ensuring compliance of the directions of Hon'ble Justice.
 - iii. That Health Officer, JMC shall further ensure that staff already deployed in the Court Complex attend their duties regularly and concerned Sanitary Inspector & Supervisors shall be held responsible for proper deployment at various locations in the court complex and shall report compliance to the Ld Court of Special Municipal Mobile Magistrate as well till further orders.
 - iv. Non-compliance of the orders and failure to do so shall warrant action against the officers / officials and Health Office shall personally visit the Court Complex and monitor the sanitation drive(s) under intimation.
