- Whereas vide Govt. order No. 212-HUD of 2018 dated 27.07.2018, sanction was accorded to the constitution of State Level Committee for Monitoring Progress of shelters to Urban Homeless under the Chairmanship of Sh. A.K Angurana, IAS (Retd.).
- Whereas 2nd meeting of State Level Committee for Monitoring Progress of shelters to Urban Homeless under the Chairmanship of Sh.. A.K Angurana, IAS (Retd.) was held on 15.09.2018, at Town Hall Jammu Municipal Corporation, Jammu to review the status of action taken of the decisions taken in the 1st meeting held on 18.08.2018 regarding progress of shelters to Urban homeless in the State of J&K.
- Whereas record note of the Minutes of Meeting issued vide No. HUD/Lit/60/2013.S.Court, among other decisions, decision No. 1 provides as under:

The concerned agencies / departments should furnish up-dated data / exact number of Homeless people indicating district / town / ULB / Corporation / ward with breakup of Homeless family identified through survey in a devised tabular format given below, including geo-tagging / mapping of the shelters already completed under construction the location, area under the shelter and the facilities being provided or

proposed. The difficulties being faced in the implementation of the scheme be also brought to the notice of the committee and the concerned Deputy Commissioners particularly regarding availability of land. The details / data should be counter signed by respective deputy Commissioners:
